

RESOLUTION NO. 5913RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
RIVERSIDE, CALIFORNIA, NAMING OCOTILLO DRIVE.

WHEREAS, certain real property in the City of Riverside,
County of Riverside, State of California, described as follows,
to wit:

That certain portion of Lot A, Osborne Heights,
as shown on map recorded in Map Book 12, Pages
39, 40 and 41, Records of Riverside County,
California, which lies adjacent to the easterly
and southeasterly line of Lot 9, the southerly
and southwesterly line of Lot 9-A, the westerly
line of Lot 6-A, the westerly and northwesterly
line of Lot 8, the northerly line of Lot 8-A,
and the northeasterly line of Lot 7-A;

has been conveyed to and accepted by the said City for public
street purposes; and,

WHEREAS, the street has not been named and the Planning
Commission of the City of Riverside has recommended the adoption
of the name Ocotillo Drive for said street.

NOW, THEREFORE, BE IT RESOLVED that the above described
street be and the same is hereby named "OCOTILLO DRIVE."

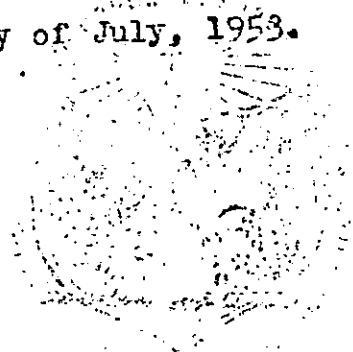
