WHEREAS, the Planning Commission of the City of Riverside has recommended, and the City Council has determined, that the names of hereinafter designated streets or portions of streets be changed, to prevent confusion from similarity of names of other streets.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside that the names of the hereinafter designated streets and portions of streets are changed as follows:

(1) PALM COURT to PATTERSON STREET; said Palm Court being described in the deed from the Riverside Abstract Company to the City of Riverside, recorded in Book 717, page 580, Official Records of Riverside County.

(2) RUBIDOUX LANE to LADERA LANE; said Rubidoux Lane being shown on the map of a portion of Rubidoux Heights recorded in Map Book 4, page 80, Riverside County Records, and also described in Ordinance No. 1004 of the City of Riverside.

(3) CODY ROAD to CARSON ROAD; said Cody Road being shown on the maps of Sun Gold Terrace Unit No. 7, recorded in Map Book 26, pages 48 and 49, and of Sun Gold Terrace Unit No. 8, recorded in Map Book 26, pages 75 and 76, of Riverside County Records.

(4) CHASE DRIVE to PANORAMA ROAD; said Chase Drive being shown on the map of Rancheria de Pachappa, recorded in Map Book 2, page 38, Riverside County Records; and described in the deed from Charles V. Brown, Jr., et al., to the City of Riverside, recorded in Book 880, page 332, Official Records of Riverside County.

(5) OPAL STREET to PETERS STREET; said Opal Street being shown on the maps of Casa Blanca Heights recorded in Map Book 5, page 117, and of St. Francis Annex No. 2, recorded in Map Book 16, page 4, Riverside County Records.

1 (6) The Portion of RUBIDOUX DRIVE, between its intersections  
2 with the southerly line of Fifth Street and the southerly line of  
3 Tenth Street, to MOUNT RUBIDOUX DRIVE; said portion of Rubidoux  
4 Drive being shown on maps of Rubidoux Heights, recorded in Map  
5 Book 7, page 30, San Bernardino County Records; and of a Portion  
6 of Rubidoux Heights, recorded in Map Book 4, page 80, Riverside  
7 County Records.

8 (7) IRVINGTON STREET to ORDWAY STREET; said Irvington  
9 Street being shown on the map of Riverview Addition Tract No. 3,  
10 recorded in Map Book 7, page 3, Riverside County Records.
