RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO. 6098.

WHEREAS, on February 9, 1954, the City Council adopted Resolution No. 6098, changing the names of certain streets in the City of Riverside. Subsequently, it was learned that there were errors in the descriptions of two of the streets, as said descriptions appear in said resolution.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside that paragraphs (1) and (5) of Resolution No. 6098 be amended to read as follows:

(1) KELLY STREET to LOMITA STREET; said Kelly Street being from Arlington Avenue northerly 963.55 feet, as shown on a map of Gafford Gardens recorded in Map Book 12 at page 97, Records of Riverside County.

(5) PRENDA STREET to MURFIELD ROAD; said Prenda Street being from the easterly line of Washington Street to the westerly line of Conduit Street, as shown on a map of Osborne Heights, recorded in Map Book 12, at page 40, Records of Riverside County.

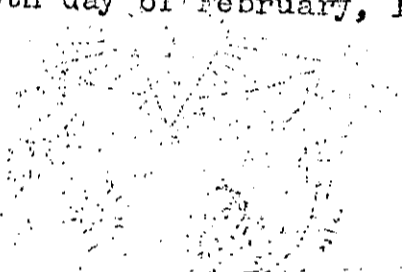
