2 RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
3 RIVERSIDE, CALIFORNIA, MAKING ITS FINDINGS AND  
4 DETERMINATIONS IN THE MANNER OF ORDINANCE OF  
5 INTENTION NO. 2120; AND ORDER OF VACATION IN  
6 THE MATTER OF VACATING A PORTION OF RIVERVIEW  
7 DRIVE (NOW KNOWN AS BACKUS DRIVE).

8 WHEREAS, the City Council of the City of Riverside, Cali-  
9 fornia, adopted an ordinance of intention, No. 2120, pursuant  
10 to the provisions of the Street Vacation Act of 1941, being  
11 Part 3, Division 9 of the Streets and Highways Code of the State  
12 of California, declaring its intention to vacate a portion of  
13 Riverview Drive (now known as Backus Drive), therein and herein-  
14 after described; and,

15 WHEREAS, the matter came on regularly for hearing before  
16 said City Council at the time and place fixed for hearing by  
17 said ordinance of intention, and said City Council heard and  
18 considered all of the evidence submitted.

19 NOW, THEREFORE, BE IT RESOLVED by said City Council that  
20 it be and is hereby found and determined by said City Council  
21 that said ordinance of intention was duly passed, adopted and  
22 published in the manner prescribed by law for the adopting and  
23 publishing of ordinances of said City, and the notice of said  
24 vacation proceedings and of the time and place of hearing was  
25 given by posting, as provided by the Street Vacation Act of 1941,  
26 and that the said portion of Riverview Drive (now known as Backus  
27 Drive) therein described is unnecessary for present or prospective  
28 public purposes and should be vacated.

29 NOW, THEREFORE, pursuant to the provisions of the said Street  
30 Vacation Act of 1941, IT IS HEREBY ORDERED by the City Council of  
31 the City of Riverside, California, that that portion of Riverview  
32 Drive (now known as Backus Drive) in the City of Riverside,  
County of Riverside, State of California, described as follows,  
to wit:

1 That portion of Riverview Drive shown on a map  
2 of Tract No. 3 of the Riverview Addition, recorded  
3 in Map Book 7, at page 5, Records of Riverside  
County, California, now known as Backus Drive,  
described as follows:

4 All that portion of said Riverview Drive, now  
5 known as Backus Drive, lying between the northerly  
6 prolongation of the easterly line of Lot 1 of Block 5  
7 of said Tract No. 3 of the Riverview Addition and the  
northerly prolongation of the westerly line of Lot 7  
of said Block and Tract;

8 be, and the same is hereby, vacated.

9 IT IS FURTHER ORDERED that the City Clerk of said City of  
10 Riverside shall cause a certified copy of this order, attested  
11 by the Clerk under the seal of said City, to be recorded in the  
12 office of the County Recorder of Riverside County, California.

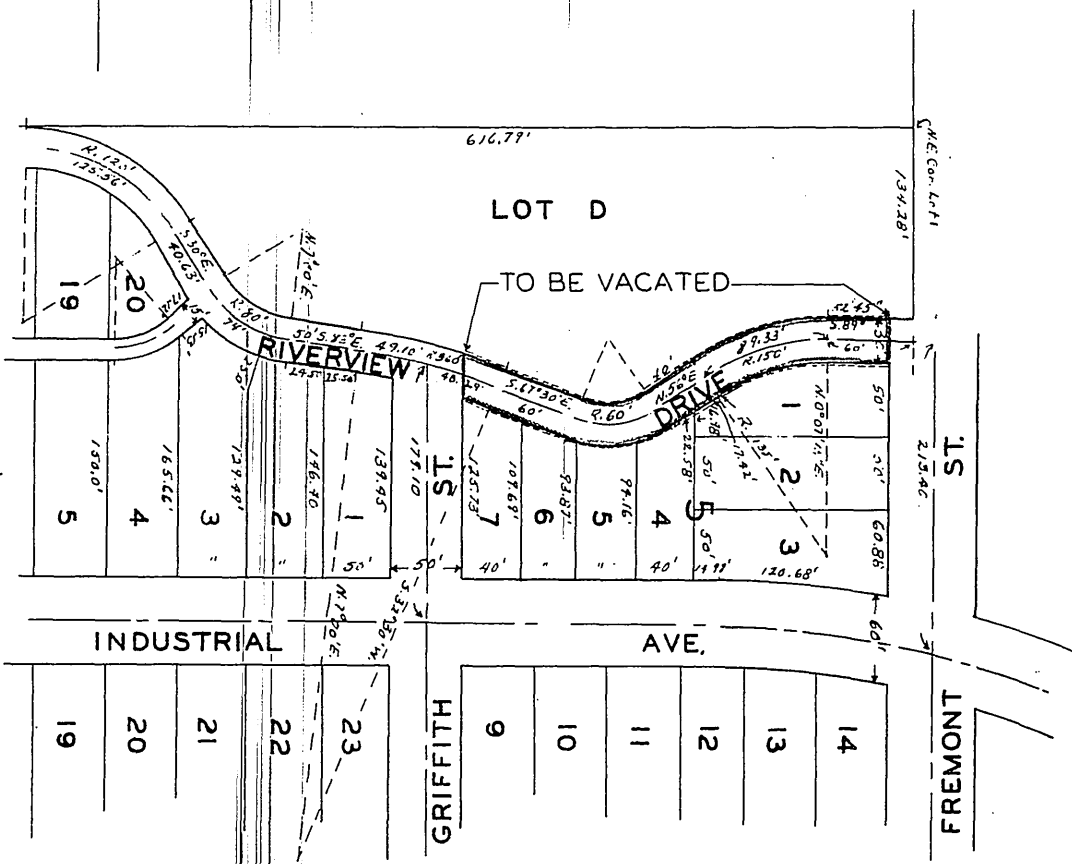
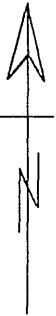
