EASEMENT

1 THIS INSTRUMENT, made this 19 day of March in the year of our Lord,
2 Nineteen Hundred and Fifty-six, between Gene H. Fisher and Margaret
3 B. Fisher, husband and wife as joint tenants, parties of the first
4 part, and the City of Riverside, a municipal corporation of the
5 State of California, the party of the second part:

6 WITNESSETH: That said parties of the first part, for and
7 in consideration of the sum of One Dollar (\$1.00), lawful money
8 of the United States of America, to them in hand paid by the said
9 party of the second part, the receipt whereof is hereby acknow-
10 ledged, do by these presents grant unto said party of the second
11 part, a perpetual easement and right-of-way for the construction,
12 reconstruction, inspection, maintenance, operation and repair of
13 SANITARY sewers, hereinafter termed "structure", in, under and
14 along that certain parcel of land in the City of Riverside, County
15 of Riverside, State of California, described as follows, to-wit:

16 The Southerly five feet (5.0') of the Northerly ten
17 feet (10.0') of Lot 13, Rockledge Park No. 3, as shown on
18 a Map recorded in Map Book 21, Page 1, Records of
Riverside County, California.

19 TOGETHER with the right to enter upon and to pass and
20 repass over and along said strip of land, and to deposit tools,
21 implements and other material thereon by said party of the second
22 part, its officers, agents, and employees, and by persons under
23 contract with it and their employees, whenever and wherever neces-
24 sary for the purpose of constructing, reconstructing, inspecting,
25 maintaining, operating or repairing said structures.

26 IN WITNESS WHEREOF, the said parties of the first part
27 have hereunto executed the within instrument the day and year first
28 above written.
