

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACCUPTING AN MASEMENT.

BE IT RESOLVED, that an desement dated May 31, 1956, executed by Homard F. Sush, Mildred Bush, James R. Spencer, Mabel M. Spencer, Gene winfrey, Lucy A. Bafrey, M. S. Olson, Floyd R. Olson, Louis Rose, Carolyn M. Rose, and This C. From and C. A. Edmonston as Trustees of the Magnolia Avenue Southern Captict Church, granting to the City of Riverside, a ramicipal corporation, a perpetual easement and right of way for the construction, reconstruction, inspection, maintenance, operation and repair of sanitary sewers in, under and along portions of Lots 15 and 16, Block 11, Riverside Land and Irrigating Company mands, being more particularly described in said Easement, be, and the same is hereby officially accepted.
