A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING PORTIONS OF PUBLIC UTILITY EASEMENTS OVER LOTS 21 AND 26, PRINCE ALBERT ESTATES UNIT NO. 2

WHEREAS, on the 24th day of June, 1956, Ordinance No. 2376 of the City of Riverside, California, was adopted, declaring the intention of the City Council to vacate portions of public utility easements over lots 21 and 26, Prince Albert Estates Unit No. 2, pursuant to the provisions of the Public Service Easements Vacat-
tion Law; and,

WHEREAS, in said ordinance the time of hearing was set for Tuesday, August 21, 1956, at 10:00 o'clock A. M. in the Council Chamber located in the City Hall, Seventh and Orange Streets, Riverside, California, at which said time and place all persons interested in or objecting to the proposed vacation be allowed to be heard; and,

WHEREAS, notice of hearing was given as provided by Section 50441 of the Government Code of the State of California; and,

WHEREAS, a hearing of the ordinance of intention was had before said legislative body at the time and place fixed, at which time the evidence offered by persons interested was heard by the legislative body, and the legislative body found from all of the evidence submitted that the portions of the public utility easements which the legislative body declared its intention to vacate are unnecessary for present or prospective public use.

NOW, THEREFORE, IT IS ORDERED by the City Council of the City of Riverside, California, that the portions of the public utility easements over lots 21 and 26, Prince Albert Estates Unit No. 2, in the City of Riverside, County of Riverside, State of Cali-
fornia, and described as follows:

The westerly five feet (5') of lot 21, except the northerly ten feet (10') thereof; and the easterly five feet (5') of lot 26, all as shown

1 on a map of Prince Albert Station Unit No. 2,
2 recorded in Map Book 28, at page 37, Records of
3 Riverside County;

4 are intended for present or prospective public use, and that
5 the same do and are hereby vacated.

6 IT IS FURTHER ORDERED that the City Clerk cause a certified
7 copy of this order, attested by him by his under seal, to be
8 recorded in the Office of the County Recorder of Riverside County,
9 California.
