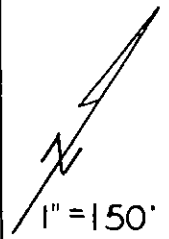

MAGNOLIA VILLAGE TRACT

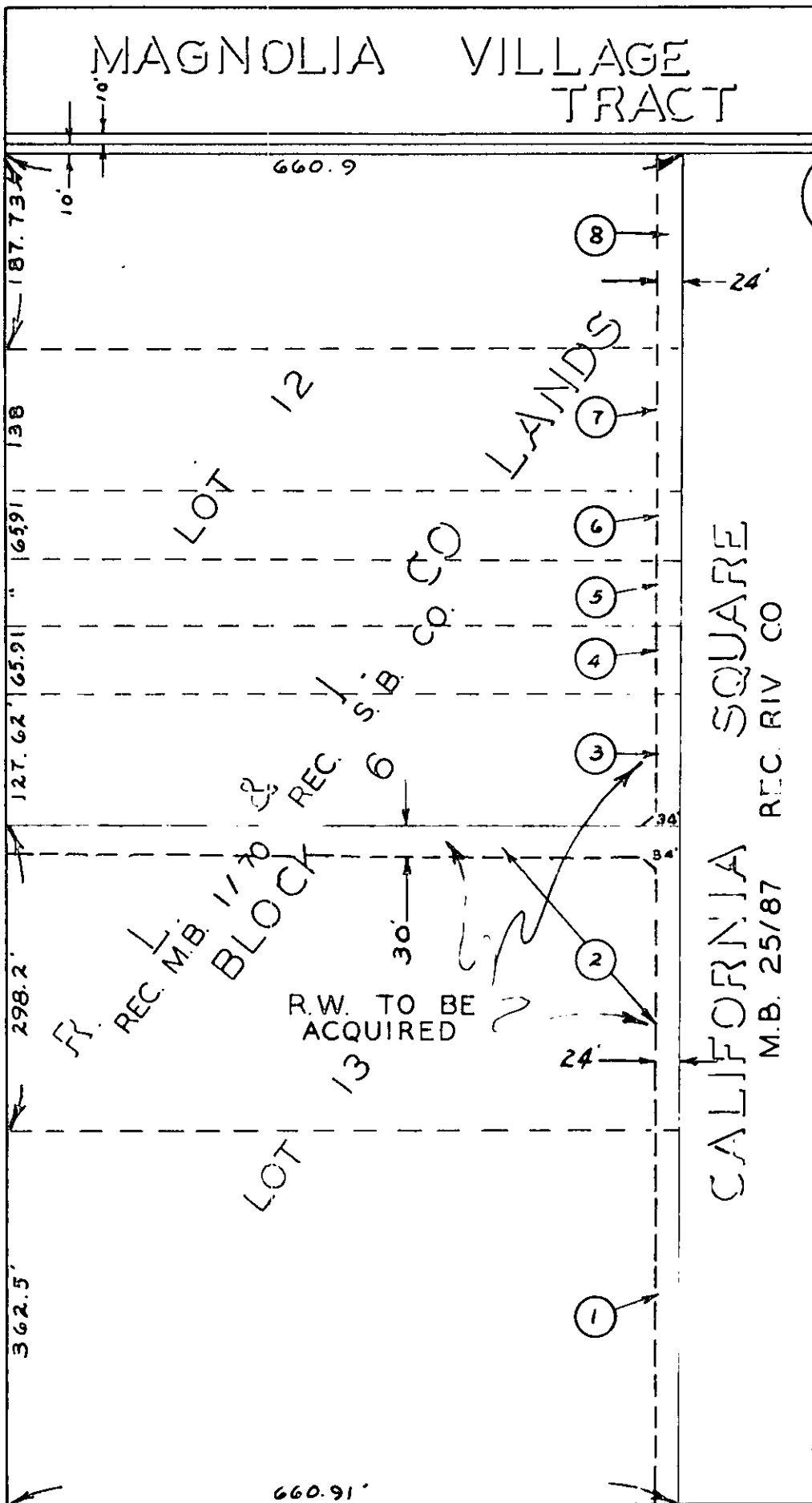


ADAMS STREET

RIVERSIDE, CALIFORNIA, ACCEPTING A DEED.


