

RESOLUTION NO. 7438

1 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
2 RIVERSIDE, CALIFORNIA, MAKING ITS FINDINGS AND
3 DETERMINATIONS IN THE MATTER OF ORDINANCE OF
4 INTENTION NO. 2316; AND ORDER OF VACATION IN THE
5 MATTER OF VACATING A PORTION OF ELSINORE ROAD.

6 WHEREAS, the City Council of the City of Riverside, Cali-
7 fornia, adopted an ordinance of intention No. 2316 pursuant to
8 the provisions of the Street Vacation Act of 1941, being Part 3,
9 Division 9 of the Streets and Highways Code of the State of
10 California, declaring its intention to vacate a portion of
11 Elsinore Road, therein and hereinafter described; and,

12 WHEREAS, the matter came on regularly for hearing before
13 said City Council at the time and place fixed for hearing by
14 said ordinance of intention, and said City Council heard and
15 considered all of the evidence submitted.

16 NOW, THEREFORE, BE IT RESOLVED by said City Council that
17 it be and is hereby found and determined by said City Council
18 that said ordinance of intention was duly passed, adopted and
19 published in the manner prescribed by law for the adopting and
20 publishing of ordinances of said City, and the notice of said
21 vacation proceedings and of the time and place of hearing was
22 given by posting, as provided by the Street Vacation Act of 1941,
23 and that the said portion of Elsinore Road therein described is
24 unnecessary for present or prospective public street purposes
25 and should be vacated.

26 NOW, THEREFORE, pursuant to the provisions of the said
27 Street Vacation Act of 1941, IT IS HEREBY ORDERED by the City
28 Council of the City of Riverside, California, that that portion
29 of Elsinore Road, in the City of Riverside, County of Riverside,
30 State of California, described as follows, to wit:

31 In the City of Riverside, County of Riverside,
32 State of California, described as follows:

All that portion of Elsinore Road adjacent,

1 appurtenant, and/or a part of Lots 8, 9, 10, 15,
2 16, and 17, as shown on map of Victoria Ranch on file
3 in Book 4, page 59 of Maps, in the Office of the
4 Recorder of Riverside County, California, which lies
5 Westerly of the Westerly line of Kansas Avenue, as
6 shown on said map, and Easterly and Southerly of the
7 following described line:

8 Commencing at the intersection of the center
9 line of Lot A (Elsinore Road) and the center line of
10 Lot B (Daventry Road), as shown on map of Victoria
11 Groves Unit No. 3, by map on file in Book 27, page 83
12 of Maps, in the office of the County Recorder of
13 Riverside County, California;

14 Thence South 19° 12' East, 30 feet to the point
15 of beginning of said aforesaid line;


16 Thence South 70° 48' West, 190 feet to the
17 beginning of a curve concave to the North, and having
18 a radius of 430 feet;

19 Thence Westerly, along the arc of said curve
20 to its intersection of the Southerly line of Elsinore
21 Road, as shown on map of Victoria Ranch aforesaid;


22 be, and the same is hereby, vacated.

24 Riverside shall cause a certified copy of this order, attested
25 by the Clerk under the seal of said City, to be recorded in the
26 office of the County Recorder of Riverside County, California.


