2 THIS INSTRUMENT, made this 20th day of June

4 GREEN BELT, INC., a corporation, party of the first part, and the
5 CITY OF RIVERSIDE, a municipal corporation of the State of
6 California, the party of the second part:

7 WITNESSETH: That said party of the first part, for a
8 valuable consideration, receipt whereof is hereby acknowledged,
9 does by these presents grant unto said party of the second part
10 a ~~perpetual~~ easement and right of way for the construction, recon-
11 struction, inspection, maintenance, operation and repair of a
12 STORM DRAIN, hereinafter termed "structure", in, under and along
13 that certain parcel of land in the City of Riverside, County of
14 Riverside, State of California, described as follows, to-wit:

15 An easement for storm drain purposes, 10 feet
16 in width lying Easterly of and adjacent to, and
17 parallel with the Westerly and Southwesterly

22 repass over and along said strip of land, and to deposit tools,
23 implements and other materials thereon by said party of the second
24 part, its officers, agents and employees, and by persons under
25 contract with it and their employees, whenever and wherever
26 necessary for the purpose of constructing, reconstructing,
27 inspecting, maintaining, operating or repairing said structures.



SHOWING STORM DRAIN EASEMENT TO BE ACQUIRED






