

RESOLUTION NO. 7827

WHEREAS THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, CHANGING NAME OF A PORTION OF GIORGETTA LANE, AND NAMING OLD RANCH ROAD,

AND WHEREAS THE City Council of the City of Riverside, upon the recommendation of the Planning Commission of said City, that the name of a portion of Giorgetta Lane described as follows:

A portion of Lot 290 of Riverside Land and Irrigation Company Lands, as shown by map on file in Book 5, page 23 of Maps, Records of San Bernardino County, California, and particularly described as:

That portion of Lot 'A' of Grandview Estates, as shown by map on file in Book 30, page 52, of Maps, Records of Riverside County, California, lying northwestern corner of a line drawn from the radius point of the property line curve at the southeast corner of Lot 4 of said Grandview Estates to the southeast corner of Lot 5 of said Grandview Estates;

to, and the same is, changed to OLD RANCH ROAD.

AND WHEREAS THE City Council of the City of Riverside that, pursuant to recommendation of the Planning Commission of said City, the parcels of land described as follows:

A uniform strip of land sixty-six feet (66') in width lying over and across portions of Lots 287, 288, 289, and 290 of the Riverside Land and Irrigation Company Lands, as shown by map on file in Book 5, page 23 of Maps, Records of San Bernardino County, California, being more particularly described as follows:

That portion of said Lot 290 as conveyed by John E. DeGennaro and Gloria Jean DeGennaro, husband and wife, to the City of Riverside, by Deed recorded in Book 1892, page 127, Official Records of Riverside County, California;

Also that portion of said Lots 288, 289, and 290 shown as "Old Ranch Road" on Record of Survey on file in Book 41, page 41, Records of Survey, Riverside County, California;

Also that portion of said Lot 287 as conveyed by E. M. Bartolomei and Beatrice Bartolomei, husband and wife, to the City of Riverside by Deed recorded in Book 1891, page 424, Official Records of Riverside County, California;
