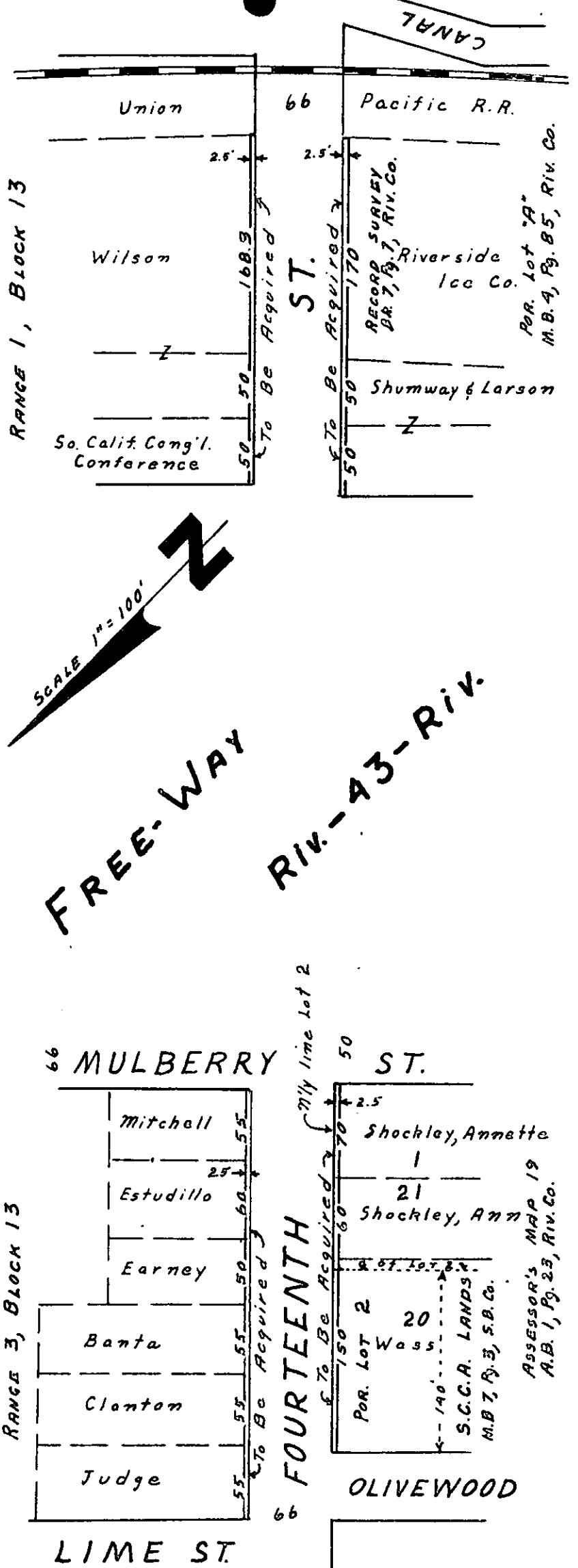

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACCEPTING EASEMENT

BE IT RESOLVED, that an Easement dated October 6, 1957, executed by James B. Judge, Margaret A. Judge, Isaac F. Banta, Helen C. Banta, Rouch H. Clanton, Estella F. Clanton, Patrick F. Earney, Minerva C. Estudillo and Lydia G. Mitchell, granting to the City of Riverside, a municipal corporation, a perpetual easement and right of way for the purpose of street lighting standards, traffic standards and controls, for public use over and along the southwesterly rectangular 2.50 feet of Block 15, Range 3 of the Town of Riverside, as shown on map recorded in Book 7, Page 17 of Maps, Records of San Bernardino County, California, be, and the same is hereby, officially accepted.
