tion No. 278 (New Series) of the City Council of the City of  
Riverside, Riverside County, California, more particularly des-  
cribed as follows:-

Commencing at the northeast corner of Lot 6, Block 7 of Tibbett's  
Tract as shown by map on file in Book 4 at page 91, of Maps,  
records of said Riverside County; Thence northerly along the  
northerly prolongation of the easterly line of said Lot 6, a  
distance of 15 feet; Thence S 89° 15' W, parallel with the  
northerly line of said Lot 6, a distance of 56.6 feet to the  
True Point of Beginning; Thence continuing S 89° 15' W, a dis-  
tance of 20 feet; Thence S 0° 45' E, a distance of 12.83 feet;  
Thence northerly, northeasterly and easterly along a curve  
concave to the southeast, with a radius of 22 feet, through an  
angle of 65° 22' 40", an arc length of 25.10 feet to a point  
of tangency at the True Point of Beginning. The initial radius  
bears S 66° 07' 40" E.
