RESOLUTION NO. 8140

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS FINDINGS AND DETERMINATIONS IN THE MATTER OF ORDINANCE OF INTENTION NO. 2599; AND ORDER OF VACATION IN THE MATTER OF VACATING A PORTION OF LOT "D" OF EL ULTIMO TRACT, BEING A PORTION OF MARIPOSA STREET.

WHEREAS, the City Council of the City of Riverside, California, adopted an ordinance of Intention No. 2599 pursuant to the provisions of the Street Vacation Act of 1941, being Part 3, Division 9 of the Streets and Highways Code of the State of California, declaring its intention to vacate a portion of Lot "D" of El Ultimo Tract, being a portion of Mariposa Street, therein and hereinafter described; and,

WHEREAS, the matter came on regularly for hearing before said City Council at the time and place fixed for hearing by said ordinance of intention and said City Council heard and considered all of the evidence submitted.

NOW, THEREFORE, BE IT RESOLVED by said City Council that it be and is hereby found and determined by said City Council that said ordinance of intention was duly passed, adopted and published in the manner prescribed by law for the adopting and publishing of ordinances of said City, and the notice of said vacation proceedings and of the time and place of hearing was given by posting, as provided by the Street Vacation Act of 1941, and that the said portion of Lot "D" of El Ultimo Tract, being a portion of Mariposa Street, therein described is unnecessary for present or prospective public street purposes and should be vacated.

NOW, THEREFORE, pursuant to the provisions of the said Street Vacation Act of 1941, IT IS HEREBY ORDERED by the City Council of the City of Riverside, California, that that portion of Lot "D" of El Ultimo Tract, Being a portion of Mariposa Street, in the City of Riverside, County of Riverside, State of California, described as follows, to wit:
