

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DIVERSIDE, CALIFORNIA, ACCEPTING A DEED

HE IT RESOLVED, that a Grant Deed, dated April 16, 1958, executed by W. H. Mercus and Forma J.
