

RESOLUTION NO. 8289

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A RIGHT OF WAY EASEMENT FOR STORM DRAIN PURPOSES IN BLOCK 13, RANGE 8 OF THE TOWN OF RIVERSIDE.

WHEREAS, on June 17, 1958, the City Council of the City of Riverside adopted a Resolution No. 8244, declaring its intention to order the vacation of a right of way easement for storm drain purposes therein described, and fixing the time and place for hearing all persons interested in the proposed vacation, pursuant to the provisions of the Public Service Easements Vacation Law, being Sections 50430 et seq., of the Government Code; and,

WHEREAS, said proposed vacation was submitted to and acted upon by the Planning Commission, and notice of hearing said resolution was given as provided by said Public Service Easements Law; and,

WHEREAS, on the day fixed for the hearing the City Council heard and considered the evidence offered by persons interested, and found, and hereby finds from all of the evidence submitted that the right of way easement for storm drain purposes hereinafter ordered vacated is unnecessary for present or prospective public use.

NOW, THEREFORE, IT IS ORDERED by the City Council of the City of Riverside, California, that a right of way easement for storm drain purposes in Block 13, Range 8, in the City of Riverside, County of Riverside, State of California, and described as follows:

That portion of that certain storm sewer as conveyed to the City of Riverside by deed recorded September 4, 1907, in Book 251, at page 209 of Deeds, records of Riverside County, California, described as follows:

Beginning at a point on the southerly line of Block 13, Range 8 of the Town of Riverside, as shown by map on file in Map Book 7, at page 17, Records of San Bernardino County, California, said point being 154 feet easterly from the southwest corner of said block; thence northerly, parallel with the westerly line of said block, 120 feet to the end.

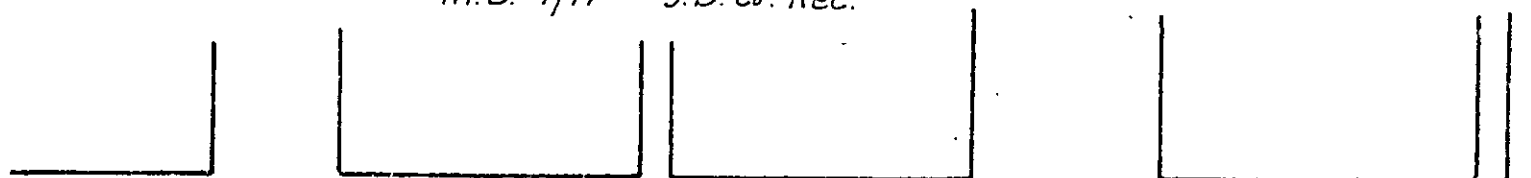

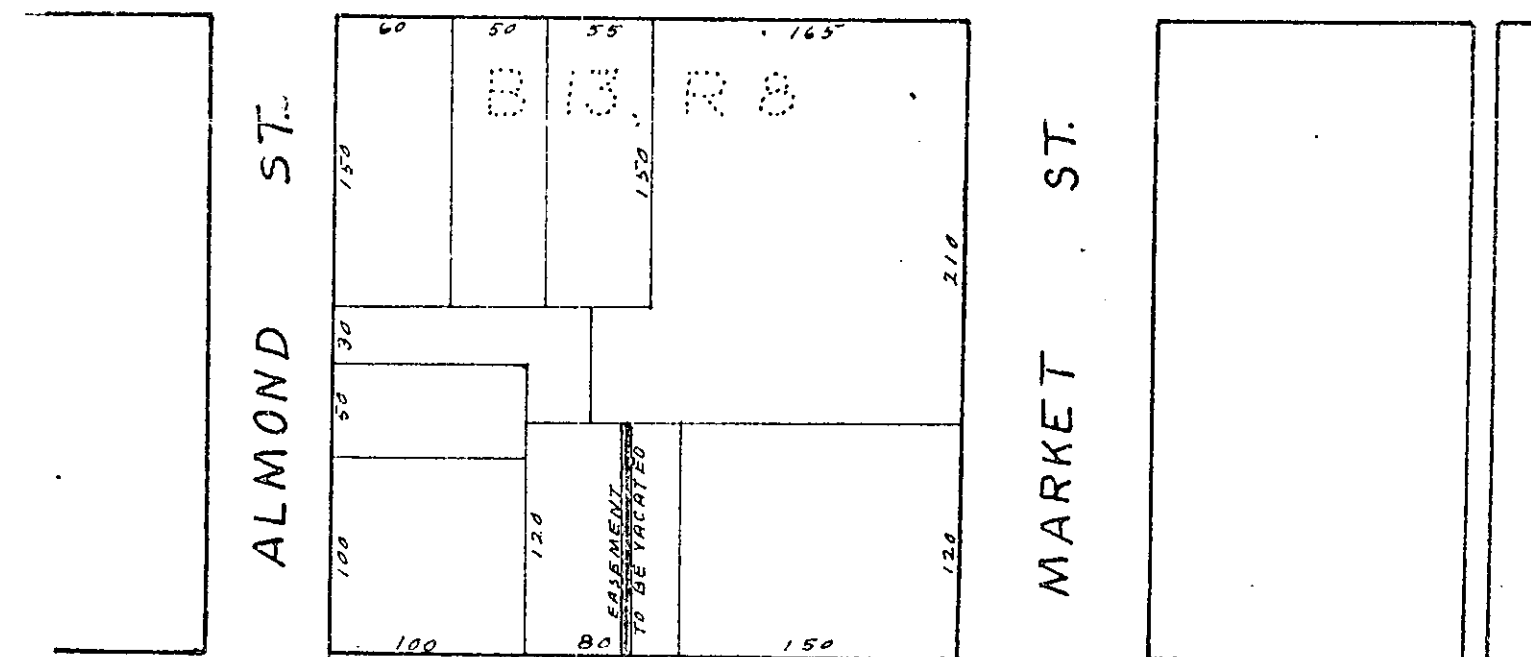
STORM DRAIN EASEMENT TO BE VACATED

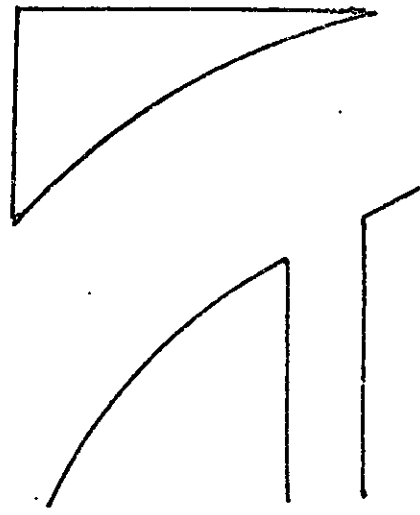
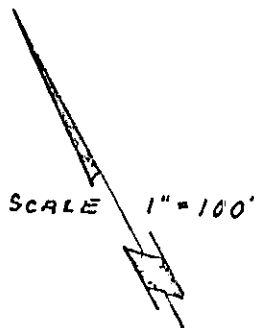
