

RESOLUTION NO. 8351

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING PART OF AN ALLEY.

WHEREAS, on August 12, 1958, the City Council of the City of Riverside adopted Resolution No. 8311 declaring its intention to order the vacation of a part of an alley, and fixing the time and place for hearing all persons interested in the proposed vacation, pursuant to the provisions of the Street Vacation Act of 1941, being Sections 8300 et seq of Part 3, Division 9 of the Streets and Highways Code of the State of California; and,

WHEREAS, said proposed vacation was submitted to and acted upon by the Planning Commission of the City of Riverside, and notice of hearing said resolution was given as provided by said Street Vacation Act of 1941; and,

WHEREAS, on the day fixed for the hearing the City Council heard and considered the evidence offered by persons interested, and found, and hereby finds, from all of the evidence submitted that the part of said alley hereinafter ordered vacated is unnecessary for present or prospective public use.

NOW, THEREFORE, IT IS RESOLVED AND ORDERED by the City Council of the City of Riverside, California, that the part of an alley, in the City of Riverside, County of Riverside, State of California, and described as follows:

The westerly 231.00 feet of the alley which runs easterly and westerly through Block 22 of the Santa Fe Tract, as shown by map on file in Book 6, page 14 of Maps, records of San Bernardino County, California,

is unnecessary for present or prospective public use, and that the same be and is hereby vacated.

IT IS FURTHER ORDERED that the City Clerk of said City of Riverside shall cause a certified copy of this order, attested

2 in the office of the County Recorder of Riverside County,

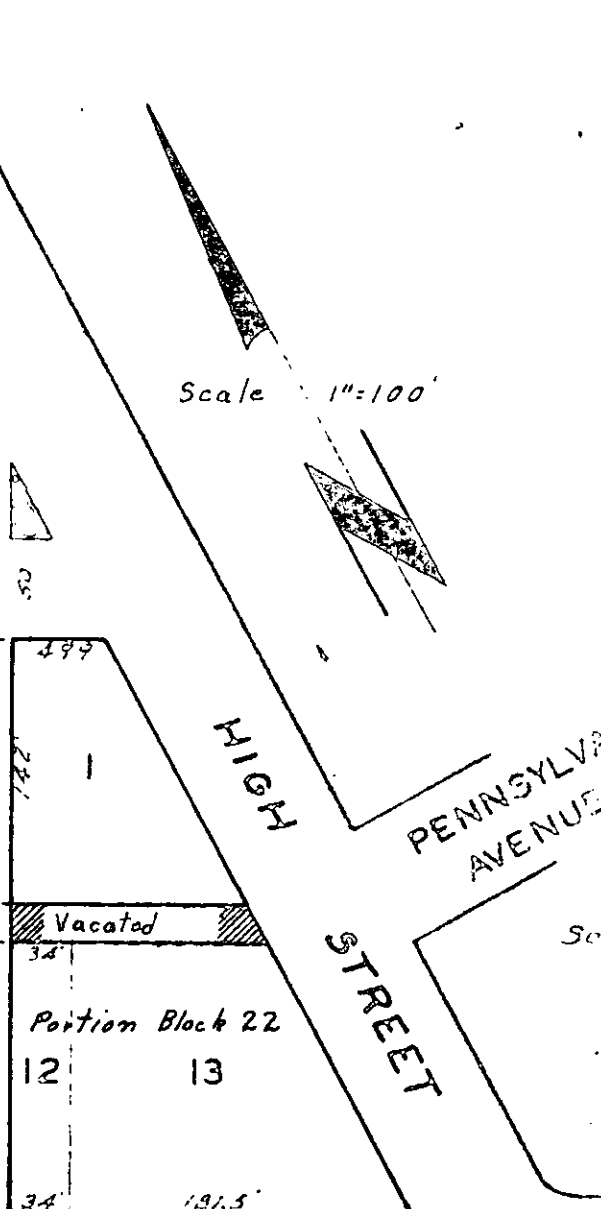
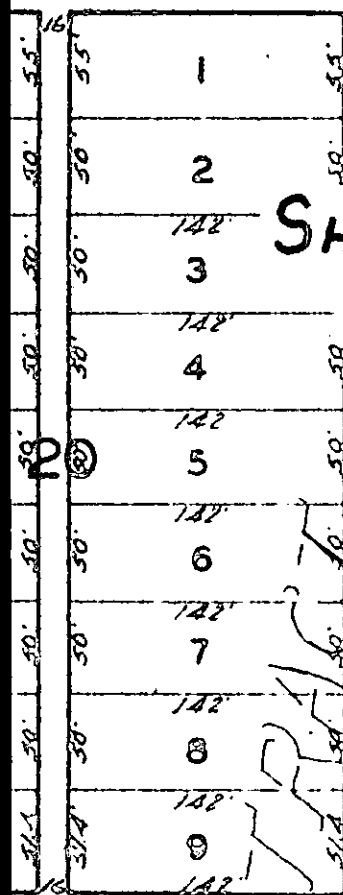

STREET 25

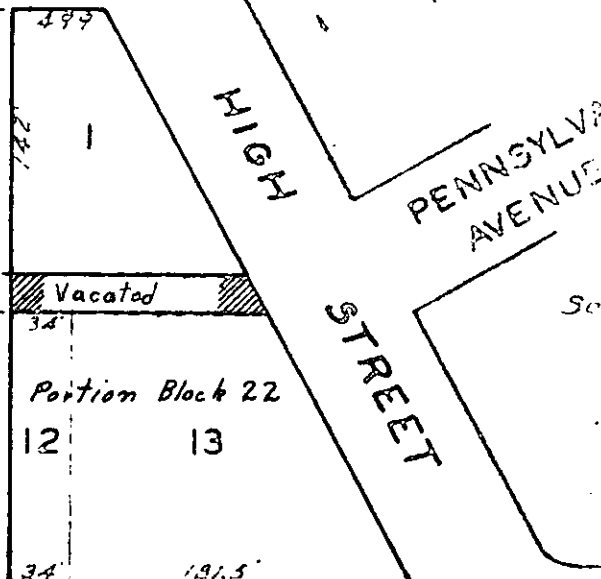
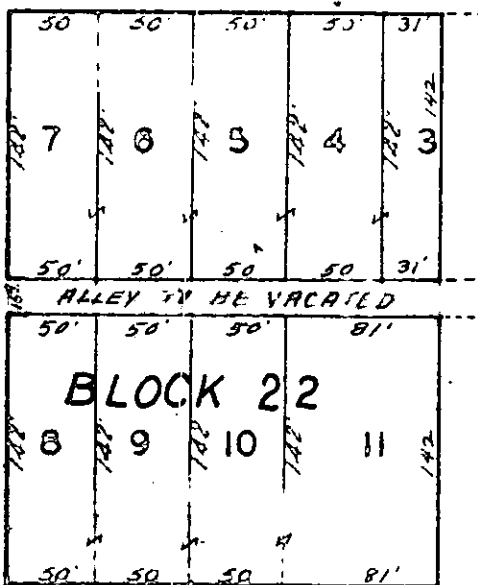
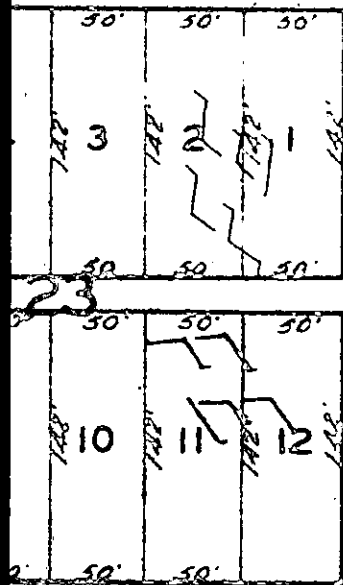
PLAT

SHOWING ALLEY TO BE VACATED



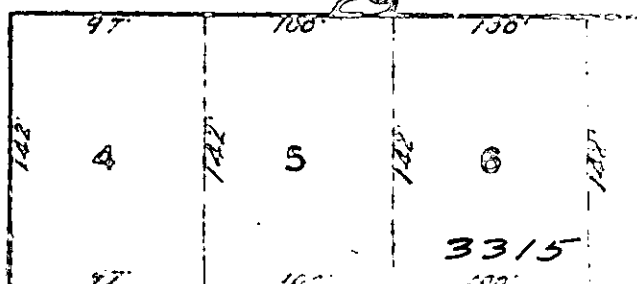
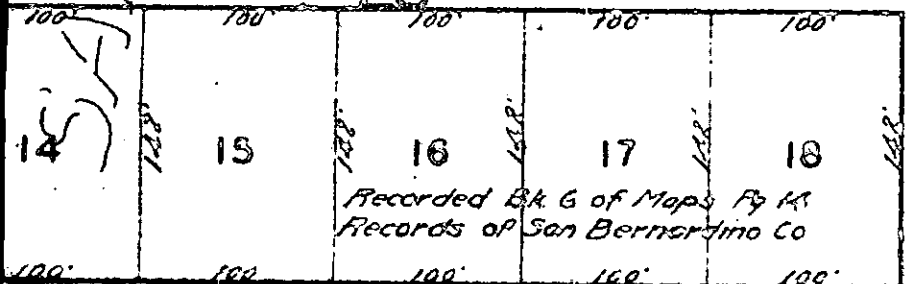
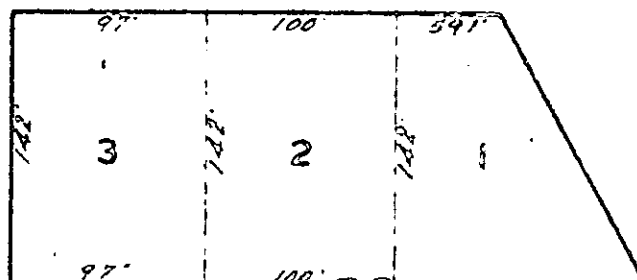
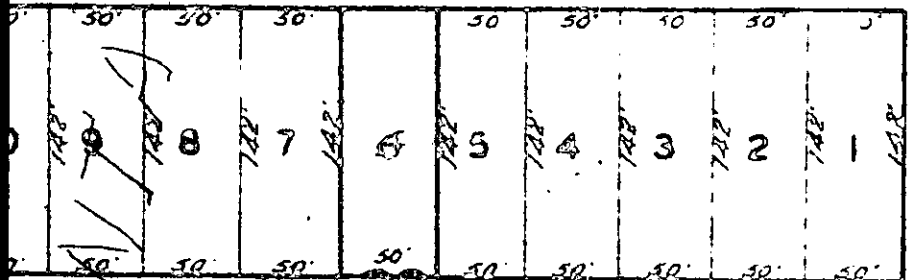
COTTAGE
