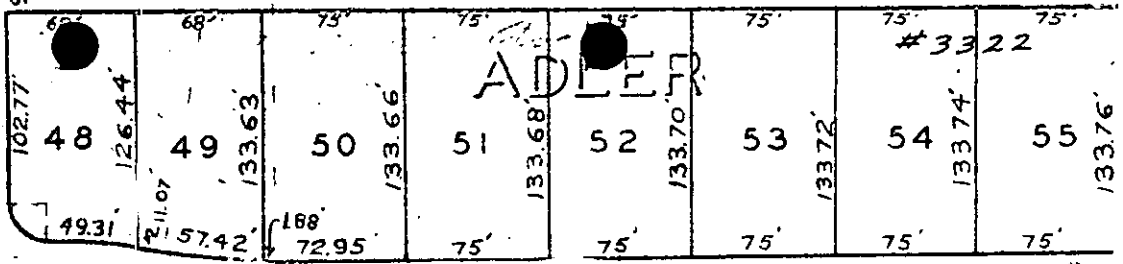

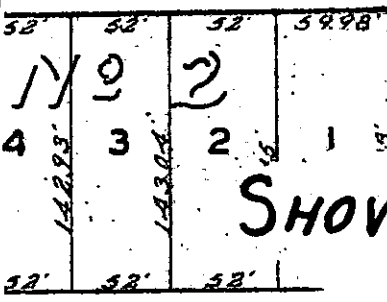

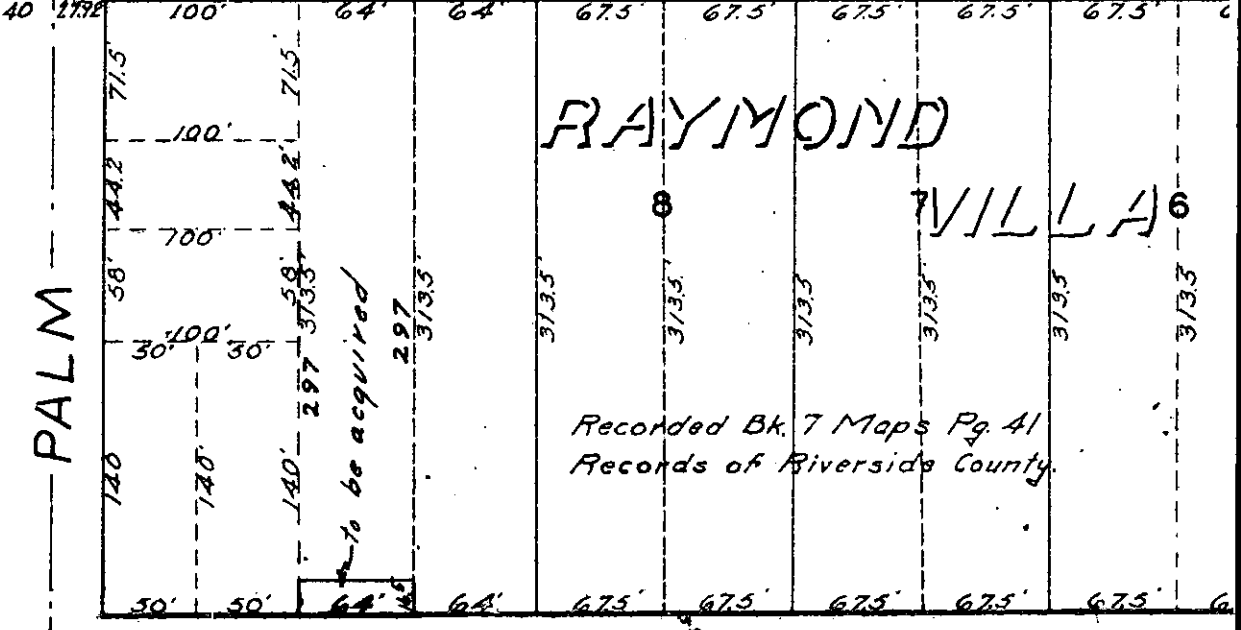
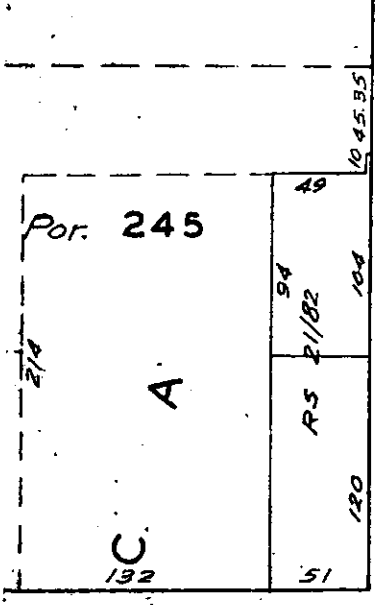
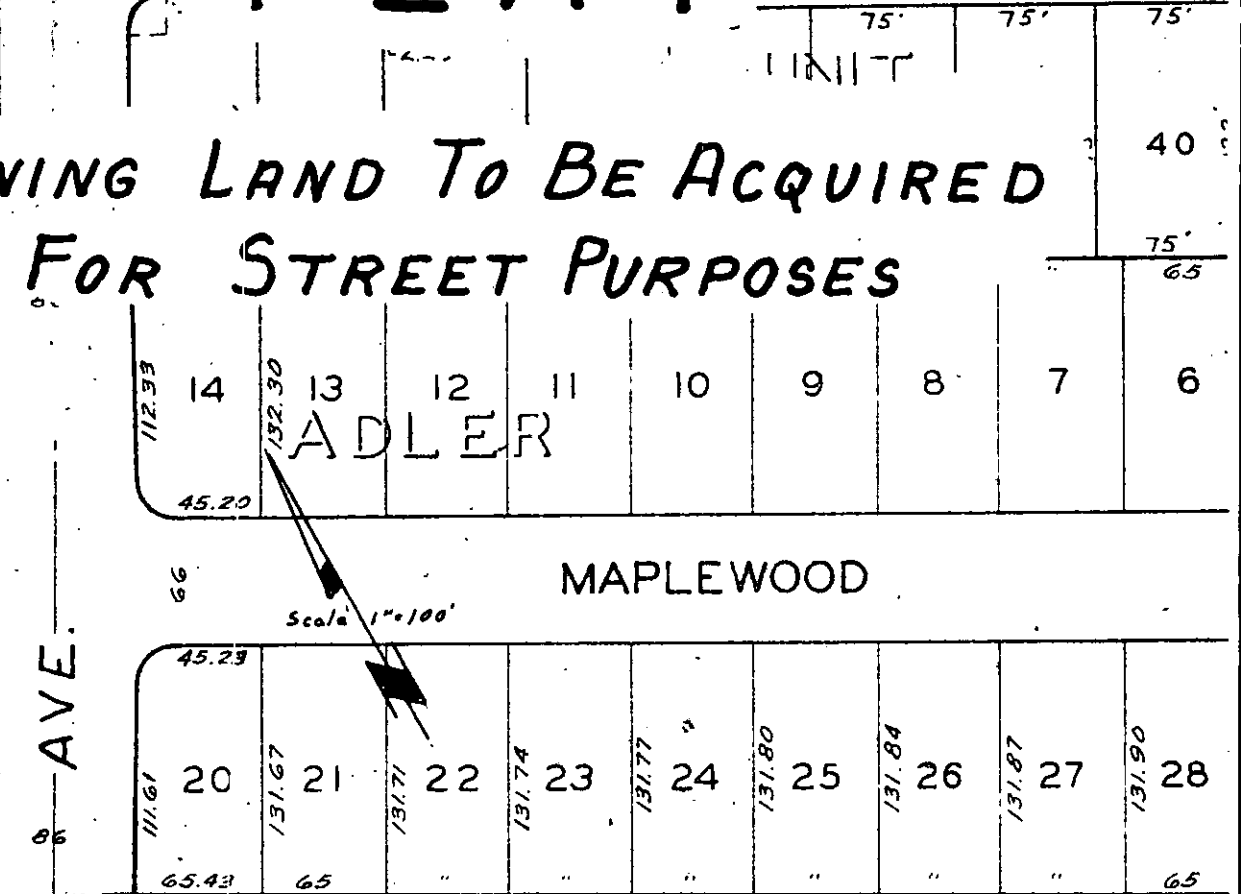
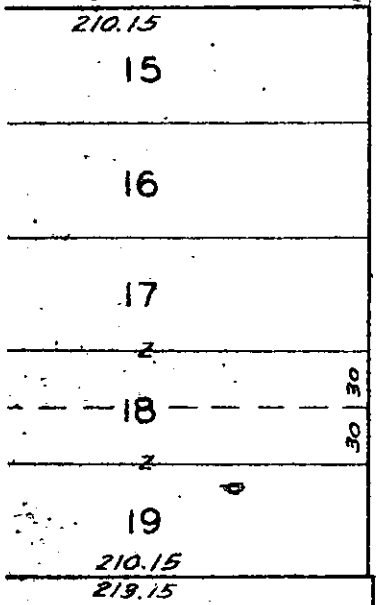


TWOOD AVE. 50'
