RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACCEPTING AND NAMING DIANA AVENUE AS A CITY STREET.

RESOLVED by the City Council of the City of Riverside that the name "DIANA AVENUE" be and is hereby adopted for and applied to the street located on the land in the City of Riverside, County of Riverside, State of California, described as follows:

That certain right-of-way parallel with and adjacent to the northwesterly side of the State Freeway VIII Riv.-43-Riv. between Arlington Avenue and the southwesterly boundary of the City of Riverside; said right-of-way serving as a connecting street between the following streets:

Harding Street to Ma Kinley Street; McKinley Street to Washington Street;
Cortez Street to Verde Street;
Lila Street to Susan Street;
Crowell Avenue to Adams Street; Adams Street to Monroe Street;
Jackson Street to Wilbur Street; Wilbur Street to Donald Avenue; Donald Avenue to Sidney Street;
Myers Street to Harrison Street; Harrison Street to Tyler Street; Tyler Street to the southwesterly City limits;

and that said street be and is hereby accepted as a City street.

Said street is accepted and so named after receiving and considering the recommendation of the Planning Commission of the City of Riverside.

ADOPTED by the City Council and signed by the Mayor and attested by the City Clerk this 23rd day of December, 1958.

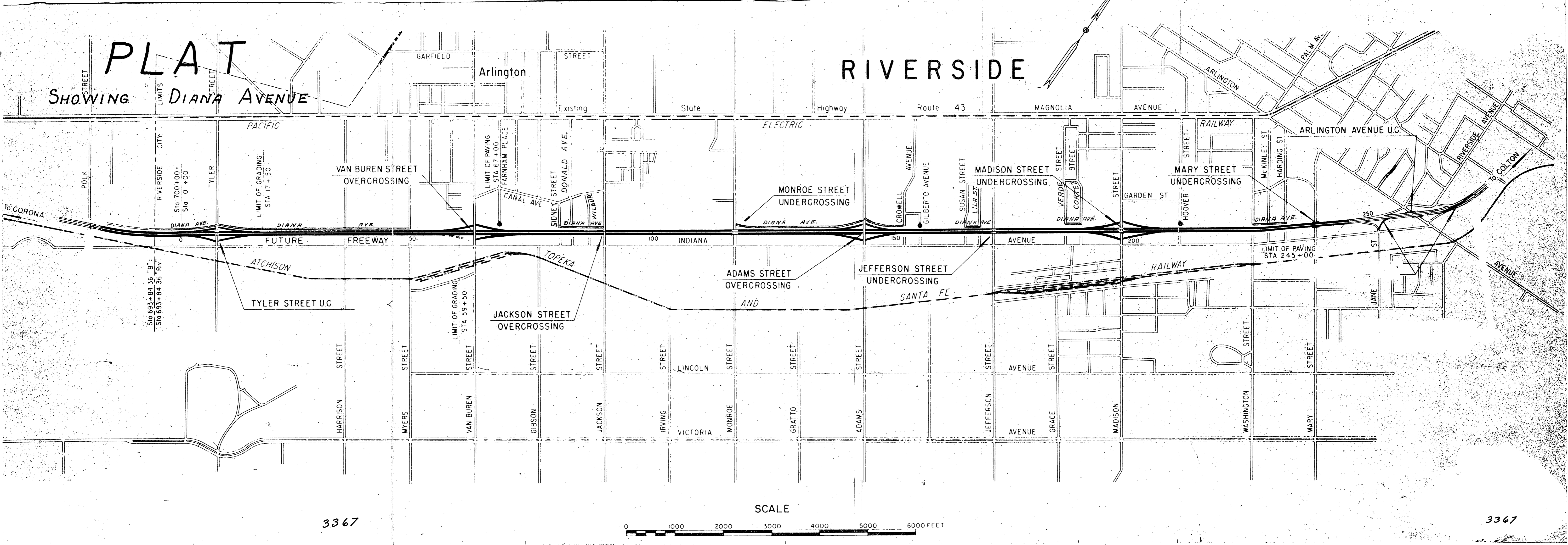
