DEPT OF PUBLIC WORKS

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, CHANGING THE NAME OF KINLEY AVENUE TO GRANFORD AVENUE.

WHEREAS, the Planning Commission of the City of Riverside has recommended that the name of Mc Kinley Avenue be changed to Granford Avenue, said street being more particularly described as follows:

That portion of Mc Kinley Avenue, 66 feet in width, lying adjacent to the easterly line of Lot 2, Block 1, as shown by map of Subdivision of Section 30, Township 2 South, Range 4 West, San Bernardino Base and Meridian, on file in Book 2, page 37 of Maps, records of Riverside County, California; also that portion of the proposed extension of Mc Kinley Avenue more particularly described as the westerly 33.00 feet of Lots 24 and 25 and the easterly 33.00 feet of Lot 26, as shown on map of Lands of the East Riverside Land Company, on file in Book 5, page 44 of Maps, records of San Bernardino County, California.

And, WHEREAS, the City Council has determined that it is to the best interest of the City that the name of Mc Kinley Avenue be changed to Granford Avenue,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside that the name of Mc Kinley Avenue is hereby changed to Granford Avenue.

ADOPTED by the City Council and signed by the Mayor and attested by the City Clerk this 23rd day of December, 1958.
