DEPT OF PUBLIC WORKS

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A RIGHT OF WAY EASEMENT FOR PUBLIC UTILITY PURPOSES IN, OVER AND ACROSS LOT 15 OF EL RIO RANCHO.

WHEREAS, it appears that the City of Riverside has an easement and right of way for public utility purposes in, over and across Lot 15 of El Rio Rancho, along the course hereinafter described: and,

WHEREAS it appears that said easement and right of way is no longer necessary for present or prospective public use;

NOW, THEREFORE, IT IS ORDERED by the City Council of the City of Riverside, California, that said easement and right of way for public utility purposes be and the same is hereby vacated. The said easement is situate in the City of Riverside, County of Riverside, State of California, and is described as follows:

The Southerly Ten (10) feet of Lot Fifteen (15) of El Rio Rancho, as shown by map on file in Book 29, pages 41 and 42 of Maps, Records of Riverside County, California.

IT IS FURTHER ORDERED that the City Clerk of said City of Riverside shall cause a certified copy of this resolution and order, attested by the City Clerk under the seal of said City, to be recorded in the office of the County Recorder of Riverside County, California.
