A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A PORTION OF A PUBLIC UTILITY EASEMENT OVER A PORTION OF LOT 1 OF LINDEN SQUARE.

WHEREAS, on the 27th day of January, 1959, Resolution No. 8487 of the City of Riverside, California, was passed and adopted declaring the intention of the City Council to vacate a portion of a public utility easement over a portion of Lot 1 of Linden Square, pursuant to the provisions of the Public Service Easements Vacation Law; and,

WHEREAS, in said resolution the time of hearing was set for Tuesday, the 24th day of February, 1959, at 10:00 o'clock A.M. in the Council Chambers of the Riverside City Council located in the City Hall, 3506 Seventh Street, Riverside, California, at which said time and place all persons interested in or objecting to the proposed vacation be allowed to be heard; and,

WHEREAS, notice of hearing was given as provided by Section 50441 of the Government Code of the State of California; and,

WHEREAS, a hearing of the resolution of intention was had before said legislative body at the time and place fixed, at which time the evidence offered by persons interested was heard by the legislative body; and the legislative body found from all of the evidence submitted that the portion of a public utility easement over portions of Lot 1 of Linden Square, which the legislative body declared its intention to vacate is unnecessary for present or prospective public use.

NOW, THEREFORE, IT IS ORDERED by the City Council of the City of Riverside, California, that the portion of a public utility easement over a portion of Lot 1 of Linden Square, in the City of Riverside, County of Riverside, State of California, and described as follows:

1 The southerly 5.00 feet of the northerly 10.00
2 feet of Lot 1 of Linden Square, as shown by map
3 on file in Book 31, page 62 of Maps, records of
4 Riverside County, California;

5 Excepting the westerly 5.00 feet thereof;

6 is unnecessary for present or prospective public use, and that
7 the same be and is hereby vacated.

8 IT IS FURTHER ORDERED that the City Clerk cause a certified
9 copy of this order, attested by her under seal, to be recorded in
10 the office of the County Recorder of Riverside County, California.

11 ADOPTED by the City Council, signed by the Mayor and attest-
12 ed by the City Clerk this 24th day of February, 1959.
