A RESOLUTION OF THE CITY COUNCIL OF THE DEPT OF PUBLIC WORKS OF RIVERSIDE, CALIFORNIA, CHANGING THE NAME OF ALESSANDRO ROAD AND A PORTION OF VICTORIA-EL SINORE ROAD TO ALESSANDRO BOULEVARD; AND CHANGING THE NAME OF A PORTION OF KANSAS AVENUE AND A PORTION OF VICTORIA-EL SINORE ROAD TO GLENHAVEN AVENUE.

BE IT RESOLVED by the City Council of the City of Riverside, upon recommendation of the Planning Commission of said City, that the name of Alessandro Road and the portion of Victoria-Elsinore Road described as follows:

Alessandro Road from its junction with Central Avenue and Fairview Avenue, as shown on map of Yorkshire Heights, Unit No. 3 on file in Book 33, page 11 of Maps, records of Riverside County, California;

Thence southerly and southeasterly to a junction with the Victoria-Elsinore Road;

Thence continuing southerly and southeasterly, along said Victoria-Elsinore Road, to the easterly boundary of the City of Riverside;

be and the same is changed to ALESSANDRO BOULEVARD.

BE IT FURTHER RESOLVED by the City Council of the City of Riverside, upon recommendation of the Planning Commission of said City, that the name of the portion of Kansas Avenue and the portion of Victoria-Elsinore Road described as follows:

Kansas Avenue from its intersection with the Southerly line of Arroyo Drive, formerly known as Luis Avenue, as shown by map of Victoria Addition to the City of Riverside, California, on file in Book 7, page 18 of Maps, records of Riverside County, California;

Thence running southerly to Fairview Avenue;

Thence continuing southeasterly and southerly, along Victoria-Elsinore Road, as shown on map of Fairview Estates on file in Book 28, pages 59 and 60 of Maps, Records of said County, and also shown as Elsinore Road on map of Church Subdivision on file in Book 6, page 55 of Maps, Records of said County, to an intersection with the easterly line of Alessandro Road;

be and the same is changed to GLENHAVEN AVENUE.
