

E A S E M E N T

THIS INDENTURE, made this 9th day of February 1968, by and between MAGNOLIA AVENUE PRESBYTERIAN CHURCH OF RIVERSIDE, party of the first part, and the CITY OF RIVERSIDE, a Municipal Corporation, in the County of Riverside, State of California, party of the Second part; WITNESSETH:

THAT in consideration of the sum of One Dollar lawful money of the United States to the party of the first part in hand paid by the party of the second part, receipt whereof is hereby acknowledged, said party of the first part does by these presents grant unto the said party of the second part, its successors and assigns, a right-of-way and easement for the construction, maintenance, operation, inspection, repair, replacement and removal of underground conduits, wires, and appurtenances, for the transmission of electric energy for any and all purposes for which the same may be used, over, and across that certain real property situate in the County of Riverside, State of California, described as follows:

The Southeasterly 5 feet of the following described property:

That portion of the Northeasterly 1/4 of Lot 2, Block 20 of Riverside Land and Irrigation Company lands as Recorded in Book 1, Page 70 of Maps, Records of San Bernardino County, California. The true point of beginning being the most Westerly corner of the Northeasterly 1/4 of said Lot 2, thence North 56° East, a distance of 137.65 feet; thence South 33° 59' 30" East, a distance of 344 feet; thence South 56° West, a distance of 137.65 feet; thence North 33° 59' 30" West a distance of 344 feet to the true point of beginning.

TOGETHER WITH the right of entry upon said premises over and across which said easement and right-of-way is granted, for the purpose of installing, maintaining and repairing said conduits and appurtenances, and to enjoy the use of said easement and right-of-way free and clear of buildings, trees and other obstructions.

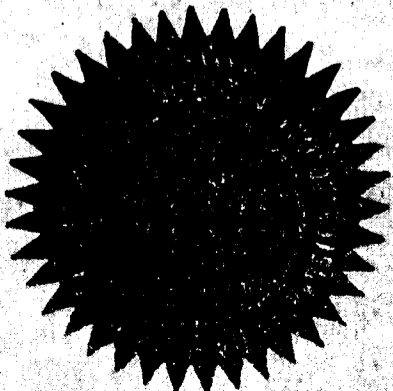

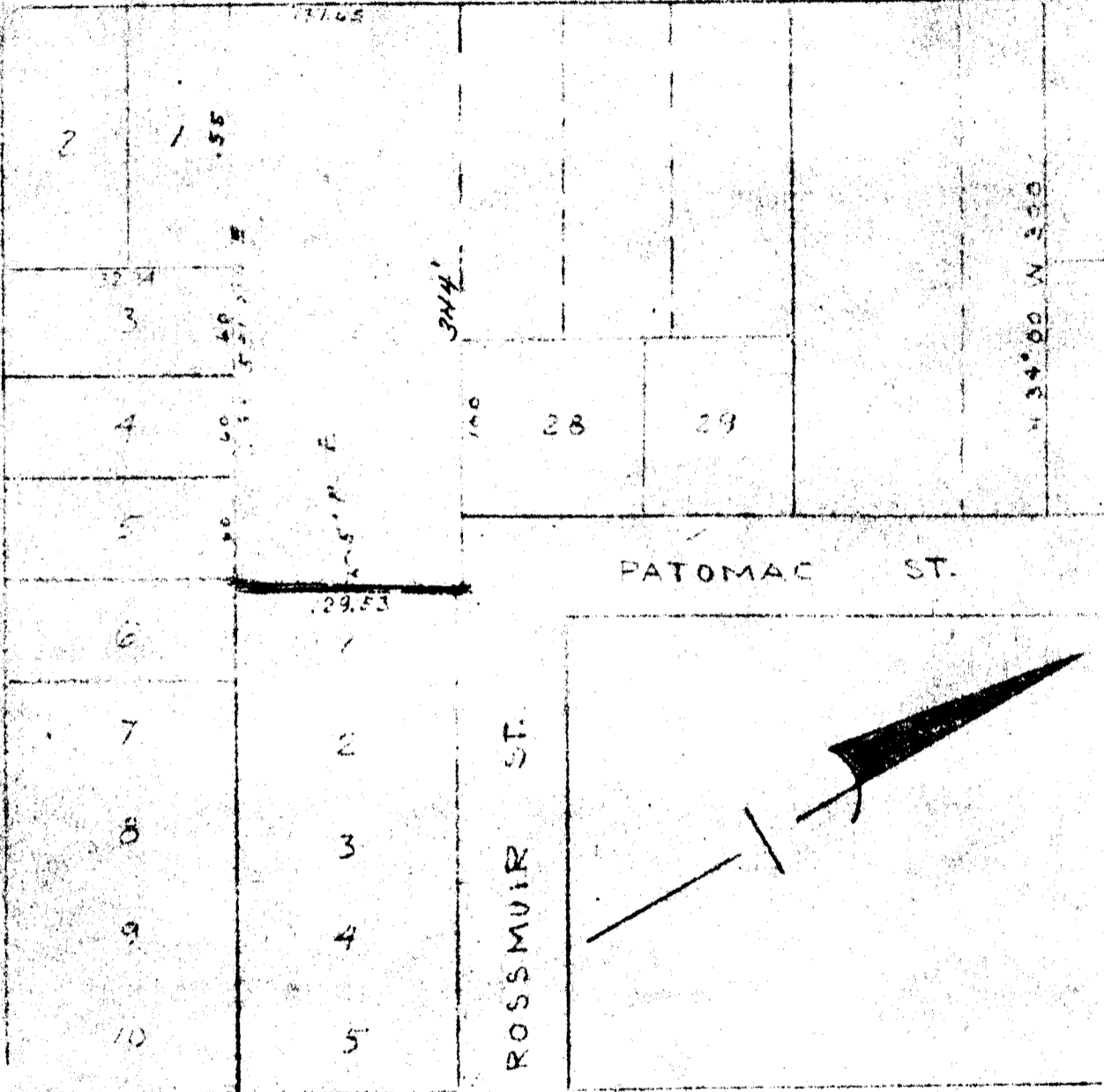
