

RESOLUTION NO. 8575

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS ORDER VACATING A RIGHT OF WAY EASEMENT FOR DRAINAGE PURPOSES IN, OVER AND ACROSS LOT 3 IN BLOCK 7 OF LANDS OF THE RIVERSIDE LAND AND IRRIGATING COMPANY.

WHEREAS, it appears that the City of Riverside has an easement and right of way for drainage purposes in, over and across certain parcels of lands of the Riverside Land and Irrigating Company, along the course hereinafter described and,

WHEREAS, it appears that said easement and right of way is no longer necessary for present or prospective public use;

NOW, THEREFORE, IT IS ORDERED by the City Council of the City of Riverside, California, that said easement and right of way for drainage purposes be and the same is hereby vacated.

The said easement is situate in the City of Riverside, County of Riverside, State of California, and is described as follows:

A portion of that certain easement and right of way, 6.00 feet in width, as conveyed to the City of Riverside by deed recorded in Book 344 of Deeds, page 394, Records of Riverside County, California, the center line of said portion to be vacated lying within Lot 3, Block 7 of lands of Riverside Land and Irrigating Company, as shown by map on file in Book 1, page 79 of Maps, Records of San Bernardino County, California, parallel with and 29.00 feet southeasterly of the northeasterly line of said Lot 3.

EXCEPTING therefrom the northwesterly 120 feet and the southeasterly 40 feet of said easement and right of way.

IT IS FURTHER ORDERED that the City Clerk of said City of Riverside shall cause a certified copy of this resolution and order, attested by the City Clerk under the seal of said City, to be recorded in the office of the County Recorder of Riverside County, California.

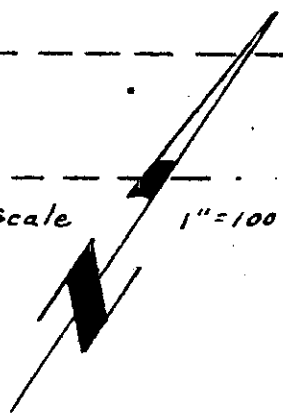
