2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE PUBLIC WORKS
3 RIVERSIDE, CALIFORNIA, MAKING ITS FINDING AND
4 DETERMINATION IN THE MATTER OF RESOLUTION OF
5 INTENTION NO. 8544; AND ORDER OF VACATION IN THE
6 MATTER OF VACATING A PORTION OF LINCOLN AVENUE.

7 WHEREAS, on April 7, 1959, the City Council of the City
8 of Riverside adopted Resolution No. 8544 declaring its intention
9 to order the vacation of a portion of Lincoln Avenue, and fixing
10 the time and place for hearing all persons interested in the
11 proposed vacation, pursuant to the provisions of the Street
12 Vacation Act of 1941, being Sections 8300 et seq. of Part 3,
13 Division 9 of the Streets and Highways Code of the State of
14 California; and,

15 WHEREAS, said proposed vacation was submitted to and
16 acted upon by the Planning Commission of the City of Riverside,
17 and notice of hearing said resolution was given as provided by
18 said Street Vacation Act of 1941; and,

19 WHEREAS, on the day fixed for the hearing the City
20 Council heard and considered the evidence offered by persons
21 interested and found, and hereby finds, from all of the evidence
22 submitted that the said portion of said street hereinafter
23 ordered vacated is unnecessary for present or prospective public
24 use.

25 NOW, THEREFORE, IT IS RESOLVED AND ORDERED by the City
26 Council of the City of Riverside, California, that the portion
27 of said street in the City of Riverside, County of Riverside,
28 State of California, and described as follows:

29 That portion of Lincoln Avenue as shown on map
30 of Arlington Heights on file in Book 11, pages
31 21 and 22 of Maps, Records of San Bernardino
32 County, California, described as follows:

Beginning at a point on the center line
of said Lincoln Avenue which bears North 35°
54' 20" East a distance of 510.43 feet from its
intersection with the center line of Anns Street,

1 said point of beginning being on a curve concave
2 southerly, with a radius of 340 feet, a radial
line at said point bears North 06° 01' 57" West;

3 Thence easterly along said curve through an
4 angle of 12° 03' 22" an arc length of 71.54 feet
to intersect the southeasterly line of said
Lincoln Avenue;

5 Thence North 55° 54' 20" East along said
6 southeasterly line, 259.83 feet to a point on a
7 curve concave westerly with a radius of 1592 feet,
8 said curve being concentric with and a radial
distance of 102 feet from the center line of
Victoria Avenue, as shown on said map, a radial
line at said point of intersection bears South 71°
59' 05" East;

9 Thence northerly along said 1592 foot radius
10 curve, through an angle of 04° 28' 07" an arc
length of 124.16 feet to the northwesterly line of
said Lincoln Avenue;

11 Thence South 55° 54' 20" West, along said
12 northwesterly line, 573.83 feet to a tangent curve
13 concave southerly with a radius of 340 feet as here-
14 inbefore described;

15 Thence northeasterly along said 340 foot radius
16 curve, through an angle of 28° 03' 43", an arc length
17 of 166.52 feet to the center line of said Lincoln
18 Avenue and the point of beginning.

19 is unnecessary for present or prospective public use, and that
20 the same be and is hereby vacated.

21 IT IS FURTHER ORDERED that the City Clerk of said City
22 of Riverside shall cause a certified copy of this order, at-
23 tested by the City Clerk under the seal of said City, to be re-
24 corded in the office of the County Recorder of Riverside County,
25 California.
