We, the undersigned, of the City of Riverside, County of Riverside, State of California, hereby GRANT to the City of Riverside, a municipal corporation organized and existing under and by virtue of the laws of the State of California, a right of way for a sewer over and along the following route, to-wit:-

A strip of land extending one foot on each side of a line beginning at a point on the southerly line of Block 1, Range 12, of the Town of Riverside, as surveyed by Goldsworthy and Higbie, a plat of which is of record in the office of the County recorder of the County of San Bernardino, State of California, and one hundred and sixty-five feet (165) westerly of the southeasterly corner of said Block 1, Range 12, for an initial point; thence northerly and parallel with the easterly line of said Block 1, Range 12, a distance of three hundred and thirty feet more or less to the northerly line of said block; said line to define the middle line of a strip two feet in width to be used for sewer purposes only.
