



grantor hereby grants to the said grantee that portion of that
certain piece or parcel of land situate, lying and being in the
City of Riverside, County of Riverside, State of California, and
particularly described as follows, to-wit:-

A strip of land fifty (50) feet in width off the Westerly
side of the Southerly five (5) acres of Lot One hundred Eighty-
eight (188) and off the Westerly side of Lot One Hundred Ninety-
Seven (197) of the lands of the Southern California Colony Associa-
tion, as surveyed by Goldsworthy and Higbie, a plat of which
survey is of record in the office of the County Recorder of the
County of San Bernardino, State of California, in Book 7 of Maps
at page 3 thereof.
