

THIS INDENTURE, Made this 18th day of December, 1912, by and between T. J. BARKER AND FLORENCE A.

BARKER, his wife, of the City of Riverside, Grantors, and the CITY OF RIVERSIDE, a municipal corporation organized and existing under the laws of the State of California.

Grantee:

WITNESSETH:- That for a valuable consideration the Grantors hereby grant and convey to the said Grantee that certain piece or parcel of land situate, lying and being in the City of Riverside, County of Riverside, State of California, being particularly described as follows,

to-wit:-

Beginning on the Easterly line of Almond Street at a point 157.5 feet Southerly from the Northwesterly corner of Block 3, Range 8 of the town (now City) of Riverside, as surveyed by Coldsworthy and Higbie, a plat of which survey is of record in the office of the County Recorder of the County of San Bernardino, State of California, thence running Easterly on a line parallel with Third Street a distance of 330 feet to the Westerly line of Market Street; thence at right angles Southerly along the said Westerly line of Market Street a distance of 15 feet; thence at right angles Westerly on a line parallel with said Third Street a distance of 330 feet to the said Easterly line of Almond Street; thence at right angles Northerly along the said Easterly line of Almond Street a distance of 15 feet to the point of beginning.

TO HAVE AND TO HOLD the same unto the said Grantee for the purposes of a public alley only.
