GRANT OF RIGHT-OF-WAY.

and each of us, grant to the CITY OF RIVERSIDE, a Municipal Corporation of the State of California, an EASEMENT OF RIGHT-OF-WAY for the construction and maintenance of public sewer over and through the following described premises, situate in the City of Riverside, County of Riverside, State of California, and described as follows, to-wit:

A Strip of land four feet in width, lying two feet on each side of a line described as follows; beginning at a point on the southerly line of Weber Street and distant two feet easterly from the northwesterly corner of Lot 11 of Weber's Subdivision as recorded in Book 9 of Maps, Page 11, Records of Riverside County, California; thence southerly, parallel with and two feet from the westerly line of said Lot 11, to a point on the southerly line of said Lot 11; thence deflecting forty five degrees to the right to a point two feet easterly from the westerly line of Lot 14 of the Dr. Bogue Tract, as recorded in Book 8 of Maps, Page 72, Records of Riverside County, California; thence southerly, parallel with and two feet from the westerly line of said Lot 14, to a point on the southerly line of said Lot 14.

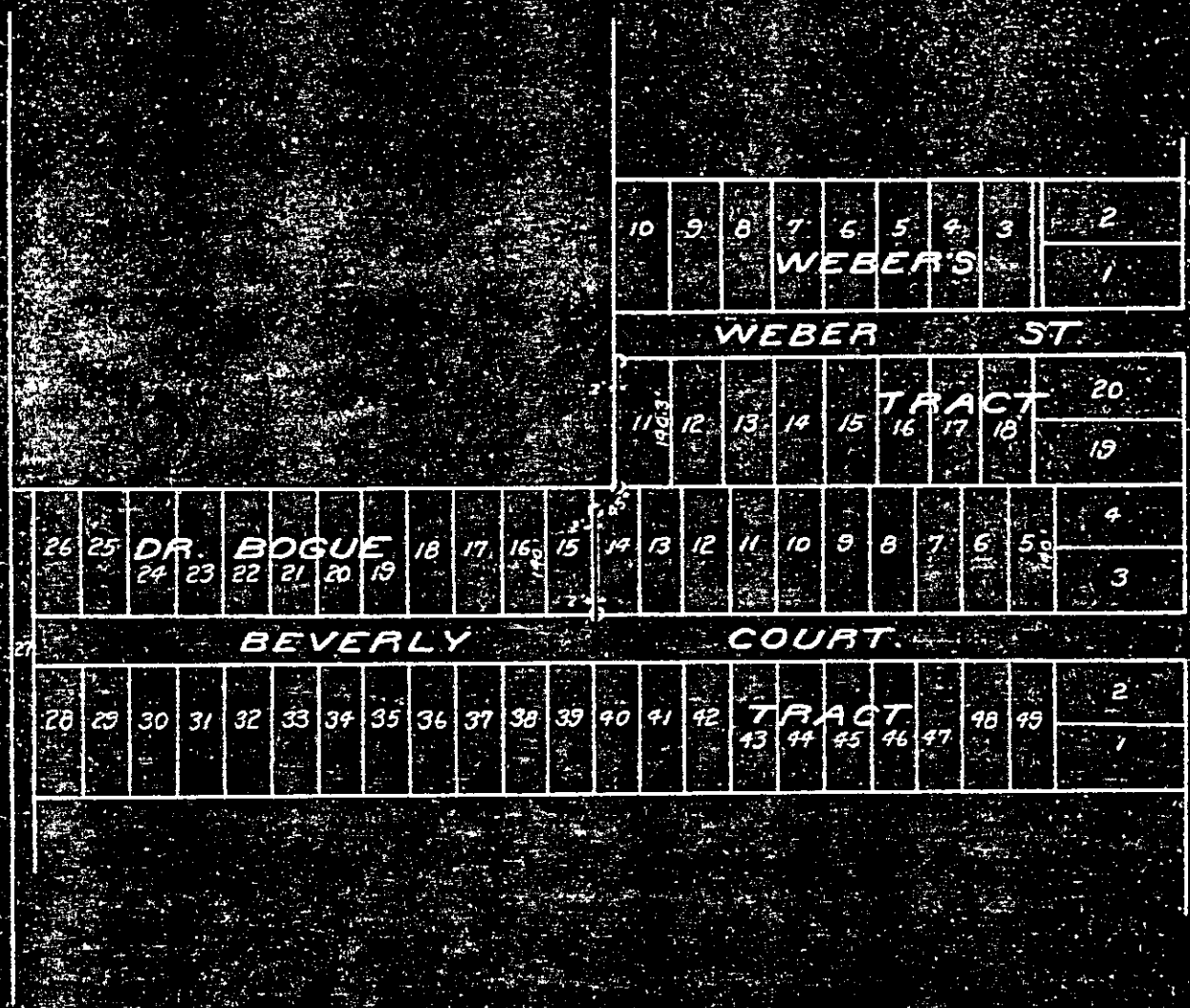
