

WE, CLAY H. WHITE AND GEORGIANA WHITE (HIS WIFE)
AND DENTON L. GASKILL (A WIDOWER)

And each of us, grant to the CITY OF RIVERSIDE, a Municipal Corporation of the State of California, an easement of Right-of-way 6 feet in width for the construction and maintenance of drainage pipe-lines over and through the following premises, situate in the City of Riverside, in Block 14 of the Riverside Land and Irrigation Company Lands, as shown on Map recorded in Book 1, Page 70 of Maps, Records of San Bernardino County, California, the center line of said 6-foot rights-of-way being described as follows, to-wit:

Beginning at a point in the northerly line, 25 feet westerly from the northeasterly corner of said Block thence southerly, parallel with the easterly side of said Block a distance of 330 feet.

Beginning at a point on the northerly line, 25 feet easterly from the northwesterly corner of Lot 1 of said Block, thence southerly, parallel with the westerly line of said Lot 1 a distance of 450 feet.

Beginning at a point on the northerly line, 25 feet easterly from the northwesterly corner of Lot 2 of said Block, thence southerly, parallel with the westerly line of said Lot 2 to the southerly line of said Lot 2.

Beginning at a point on the northerly line, 25 feet easterly from the northwesterly corner of Lot 3 of said Block; thence southerly, parallel with the westerly line of said Lot 3 and the westerly line of Lot 6 of said Block to a point distant 500 feet southerly from the northerly line of said Lot 6.
