Following said line extended to a point 17' south of boundary line of Block 6, Rockledge Subdivision, as shown in Book 4 of maps, page 56, Riverside County, thence to a point 29' east of the west boundary and 56' south of the north boundary of said lot, thence following a line parallel to the west boundary of said lot for a distance of 132' south. Thence southeasterly 151' to a point 52' south of the north boundary and 135' east of west boundary of Block 7 of said subdivision, as shown on sketch on reverse side.

Together with the right of entry upon said premises for the purpose of installing, maintaining and repairing said lines and wires, and to enjoy the use of said right of way free and clear of buildings, fences or other obstructions.

RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF RIVERSIDE ACCEPTING A DEED FOR A RIGHT-OF-WAY FOR ELECTRIC POLES, LINES AND WIRES.

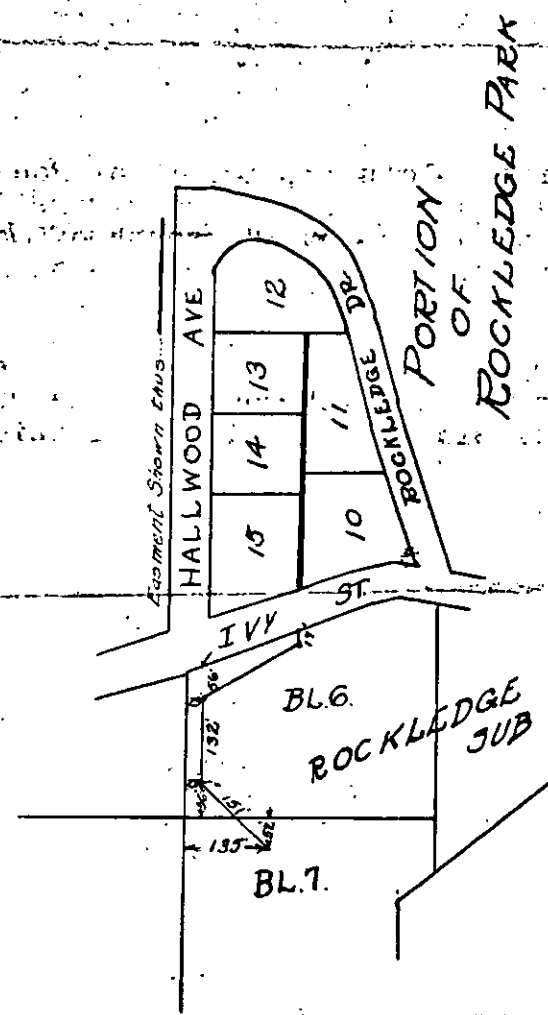
