Lily M. Merickel, a widow, hereby grants, transfers and conveys to the City of Riverside, a municipal corporation located for road purposes in the County of Riverside, California, all that certain real property located in said City of Riverside and particularly described as follows:

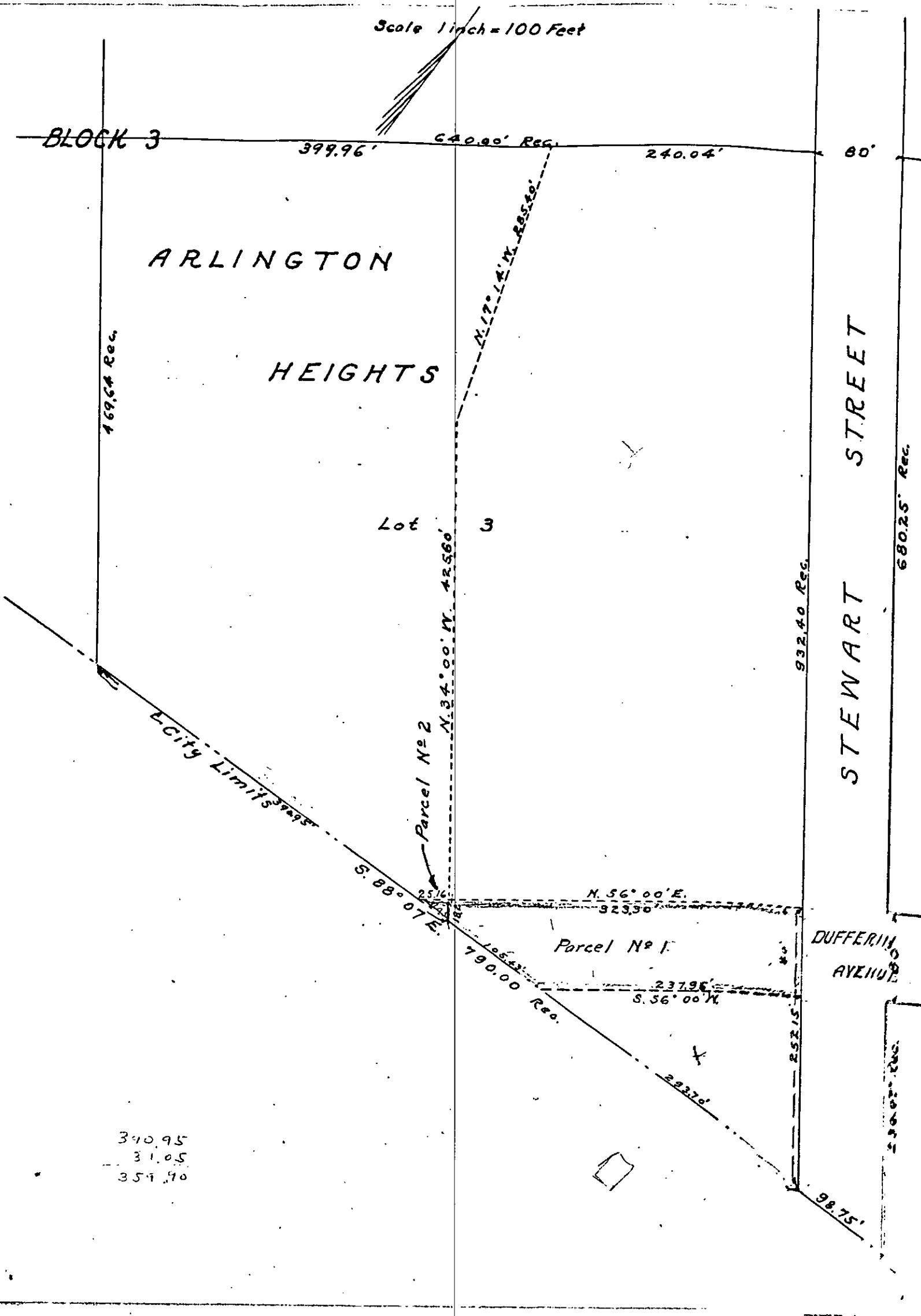
