RESOLUTION OF THE COUNCIL OF THE CITY OF RIVERSIDE  
ACCEPTING A DEED.

RESOLVED; by the Council of the City of Riverside, California, that deed dated September 25, 1929, executed by RIVERSIDE FINANCE COMPANY, a corporation, and O. K. MORTON and MAY J. MORTON, his wife, to the CITY OF RIVERSIDE, a municipal corporation, of the County of Riverside, State of California, for the following described premises situated in the City of Riverside, County of Riverside, State of California, and more particularly described as follows, to-wit:
