AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS FINDINGS AND DETERMINATIONS IN THE MATTER OF RESOLUTION OF INTENTION NO. 14033, AND MAKING ITS ORDER VACATING AN ALLEY ADJACENT TO THE ATCHISON, TOPEKA AND SANTA FE RAILROAD NEAR INDIANA AVENUE BETWEEN BARBARA COURT AND MARY STREET.

WHEREAS on April 1, 1980, the City Council of the City of Riverside adopted Resolution No. 14033 declaring its intention to order the vacation of an alley adjacent to the Atchison, Topeka and Santa Fe Railroad near Indiana Avenue between Barbara Court and Mary Street, and fixing the time and place of hearing all persons interested in the proposed vacation, pursuant to the provisions of the Street Vacation Act of 1941, being Sections 8300 et seq. of Part 3, Division 9 of the Streets and Highways Code of the State of California; and

WHEREAS said proposed vacation was submitted to and acted upon by the Planning Commission of the City of Riverside and notice of hearing said resolution was given as provided by said Street Vacation Act of 1941; and

WHEREAS on the day fixed for the hearing the City Council heard and considered the evidence offered by persons interested and found and hereby finds from all of the evidence submitted that the alley ordered vacated is unnecessary for present or prospective public use;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Riverside, California, that the alley in the City of Riverside, County of Riverside, State of California, described as follows:

PARCEL 1

The Southeasterly 20.00 feet of Lot 3 in Block 5 of Orange Acres, as shown by map on file in Book 13 of Maps, at Page 7 thereof, records of Riverside County, California.

PARCEL 2

The Southeasterly 20.00 feet of Lots 7 and 8 in Block 5 of Orange Acres, as shown by map on file in Book 13 of Maps, at Page 7 thereof, records of Riverside County, California,

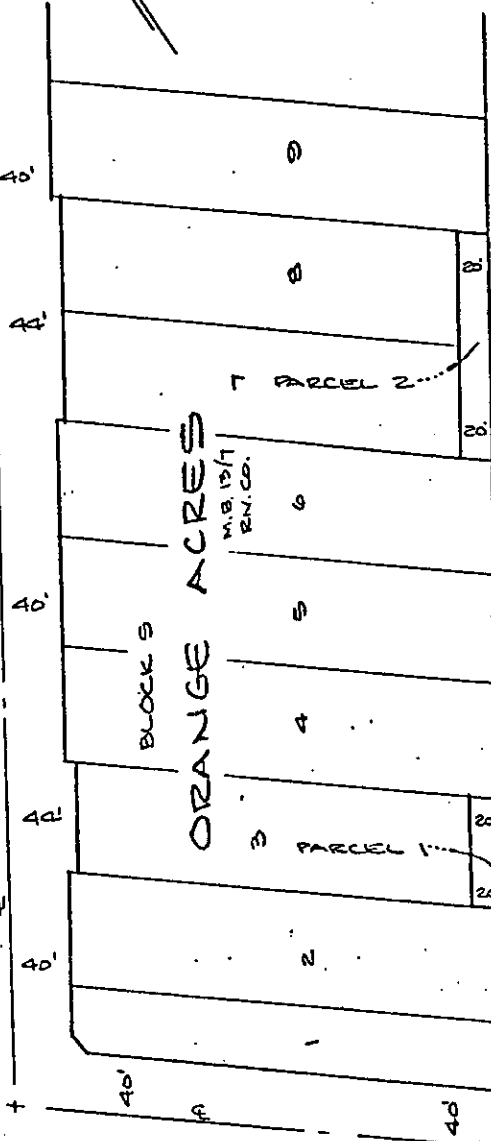
