ORDINANCE NO. 4949

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, MAKING ITS FINDINGS AND DETERMINATIONS IN THE MATTER OF RESOLUTION OF INTENTION NO. 13730, AND MAKING ITS ORDER VACATING ROMNEY STREET, AN UNIMPROVED STREET EXTENDING NORTHERLY FROM JURUPA AVENUE.

WHEREAS on July 24, 1979, the City Council of the City of Riverside adopted Resolution No. 13730 declaring its intention to order the vacation of Romney Street, a 60-foot-wide unimproved street extending northerly from Jurupa Avenue, and fixing the time and place of hearing all persons interested in the proposed vacation, pursuant to the provisions of the Street Vacation Act of 1941, being Sections 8300 et seq. of Part 3, Division 9 of the Streets and Highways Code of the State of California; and

WHEREAS said proposed vacation was submitted to and acted upon by the Planning Commission of the City of Riverside and notice of hearing said resolution was given as provided by said Street Vacation Act of 1941; and

WHEREAS on the day fixed for the hearing the City Council heard and considered the evidence offered by persons interested and found and hereby finds from all of the evidence submitted that the street ordered vacated is unnecessary for present or prospective public use;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Riverside, California, that said street in the City of Riverside, County of Riverside, State of California, described as follows:

All that portion of Romney Street (formerly Short Street) as shown by McClaskey Tract, on file in Book 10 of Maps, at Page 37 thereof, records of Riverside County, California, lying north of a line which is parallel with and distant 55.00 feet northwesterly, as measured at right angle, from the centerline of Jurupa Avenue;

be and the same is hereby vacated.

IT IS FURTHER ORDAINED that the City Clerk of said City

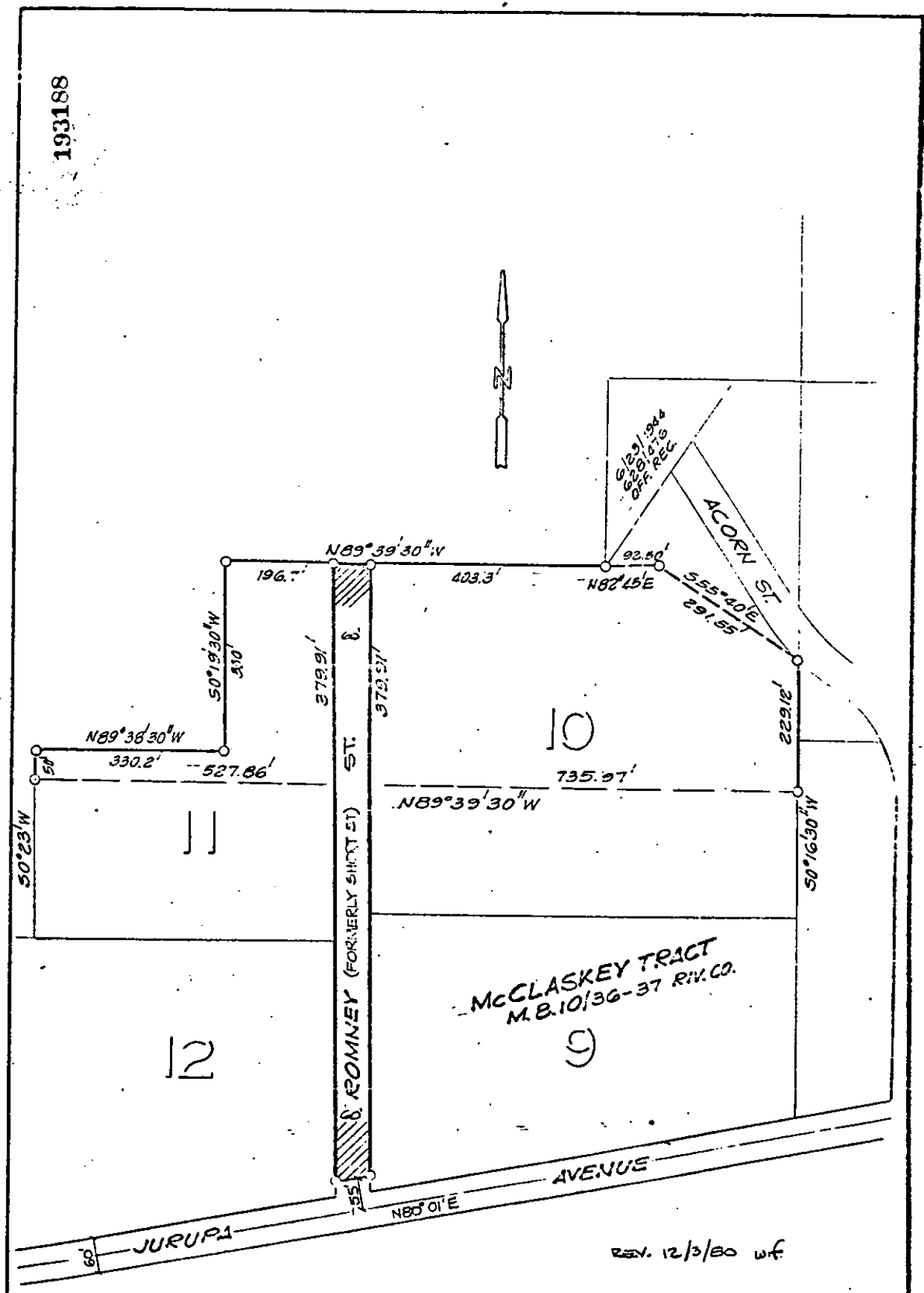
