BE IT RESOLVED by the City Council of the City of Riverside, California, pursuant to the recommendation of the Planning Commission of the City of Riverside, that the name of Bradley Street, located southwesterly of Alessandro Boulevard and southeasterly of Elsmere Drive (private street), and described as follows:

Lot A of Tract No. 10092, as shown by map on file in Book 94, Page 84 of Maps, records of Riverside County, California, together with that certain parcel of land conveyed to the City of Riverside by a deed recorded July 27, 1962, as Instrument No. 70782 of Official Records of said Riverside County, and that certain parcel of land conveyed to the City of Riverside by a deed recorded January 20, 1978 as Instrument No. 12266 of Official Records of said Riverside County;

EXCEPTING therefrom that portion vacated by the City Council of the City of Riverside by Resolution No. 13315, recorded November 21, 1977, as Instrument No. 232132 of Official Records of said Riverside County;

be changed to VIA VISTA DRIVE.

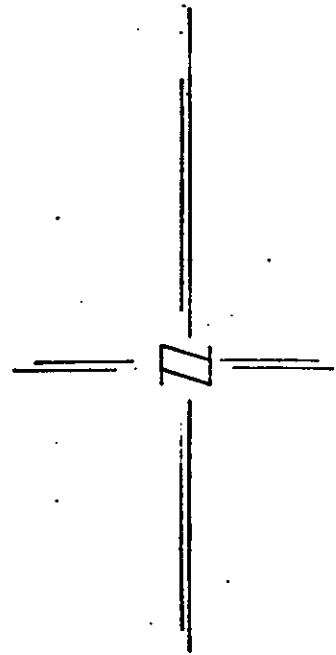
