as Grantor, grant(s) to the CITY OF RIVERSIDE, a Municipal Corporation of the State of California, as Grantee, its successors and assigns, a perpetual easement and right of way for roadway slope and support purposes, in, on, under, through, over and along that certain real property situated in the City of Riverside, County of Riverside, State of California, described as follows:

That portion of the Northwest Quarter of the Northwest Quarter of Section 18, Township 2 South, Range 4 West, San Bernardino Meridian, more particularly described as follows:

COMMENCING at the Southwest corner of Parcel 9 of Record of Survey on file in Book 41, Page 22 of Records of Survey, records of said Riverside County;

THENCE South 89° 55' 30" East, along the southerly line of said Parcel 9, a distance of 40.50 feet to the most westerly corner of that certain parcel of land conveyed to the County of Riverside by deed recorded October 10, 1960, as Instrument No. 87638 of Official Records of said Riverside County;

THENCE North 85° 15' 40" East, along the northwesterly line of said parcel so conveyed to the County of Riverside and along the northwesterly line of that certain parcel of land conveyed to the County of Riverside by deed recorded October 10, 1960, as Instrument No. 87637 of Official Records of said Riverside County, 202.58 feet;

THENCE South 89° 55' 30" East, continuing along the northerly line of said parcel conveyed to the County of Riverside as Instrument No. 87637, a distance of 60.00 feet to the northwesterly line of the A.T. & S.F. Railroad R/W as shown by said Record of Survey;

THENCE North 34° 58' 30" East, along said northwesterly line, 6.10 feet to the True Point of Beginning;

THENCE continuing North 34° 58' 30" East, along said northwesterly line, 43.00 feet;

THENCE South $41^{\circ} 53' 13''$ West, 33.24 feet;

THENCE South $74^{\circ} 47' 51''$ West, 17.04 feet;

THENCE South $89^{\circ} 24' 28''$ West, 257.57 feet;

THENCE North $51^{\circ} 01' 37''$ West, 33.75 feet to a line which is parallel with and distant 33.00 feet easterly, as measured at right angle, from the centerline of Ardmore Street as shown by said Record of Survey;

THENCE South $00^{\circ} 06' 00''$ West, along said parallelline, 7.00 feet to a point in a non-tangent curve concave to the north-east and having a radius of 39.50 feet; the radial line at said point bears South $64^{\circ} 05' 34''$ West;

THENCE Southeasterly, along said curve, an arc length of 24.04 feet through a central angle of $34^{\circ} 52' 37''$ to a line which is parallel with and distant 55.00 feet northerly, as measured at right angle, from the centerline of Columbia Avenue as shown by said Record of Survey;

THENCE South $89^{\circ} 55' 30''$ East, along said parallel line, 281.56 feet to said True Point of Beginning.

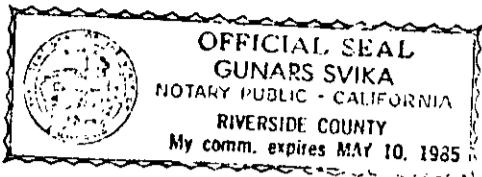

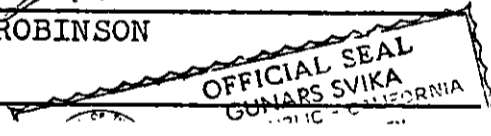

Provided, however, that the Grantor(s) reserve(s) the right of use and enjoy the land over which said easement and right of way is granted, for any purpose and in any manner which does not interfere with or impair the right of the Grantee to use said easement and right of way.

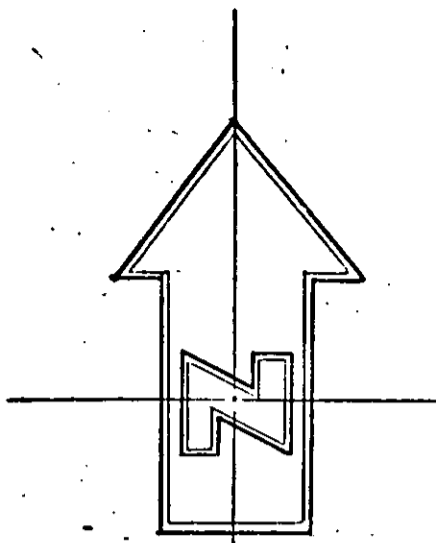
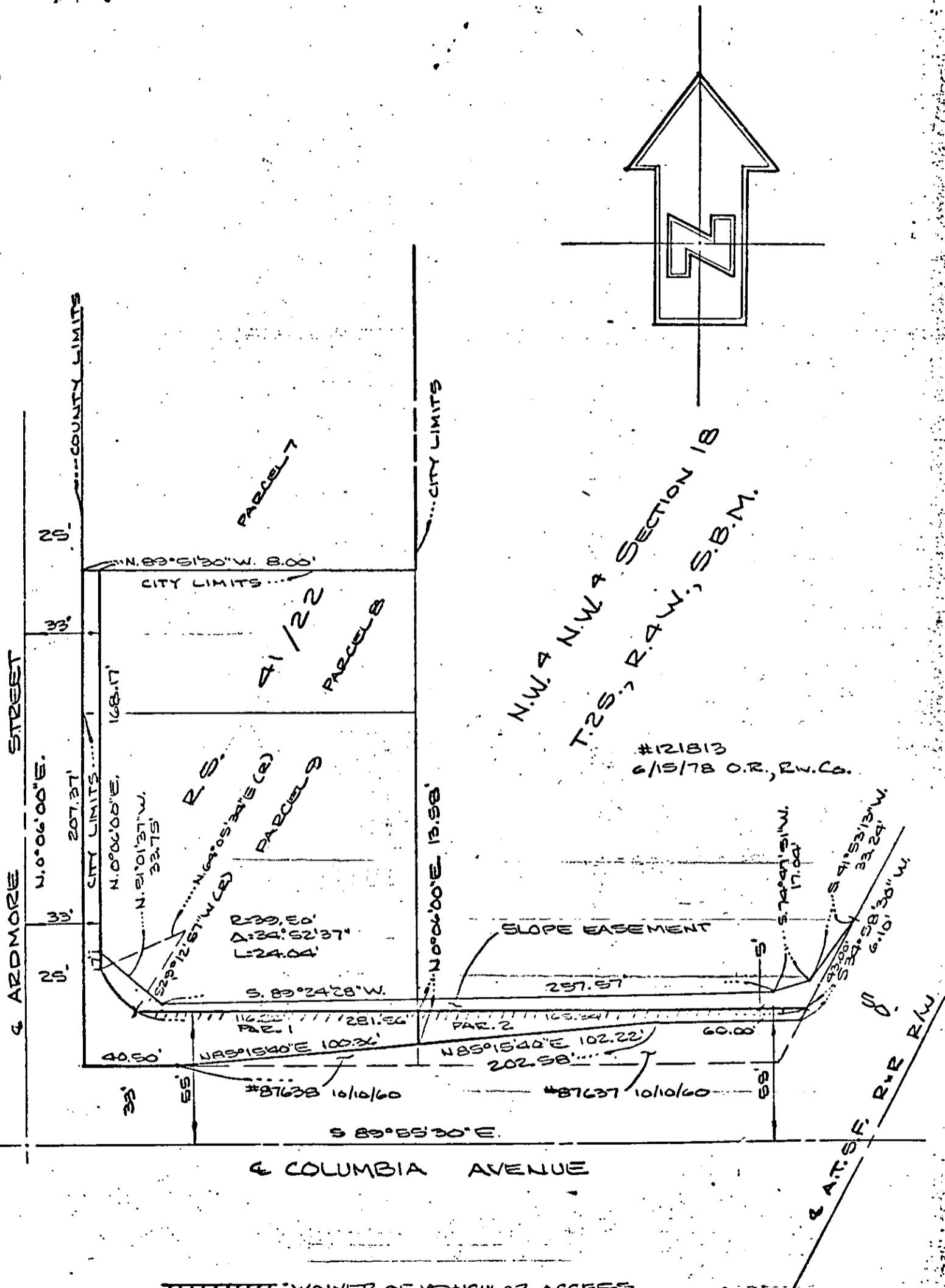
