Riverside, its officers, employees, agents or contractors.

Upon completion of construction, the City of Riverside shall remove all
debris, waste or excess material, brush or other matter of material deposited or
placed upon the land, and with the exception of vegetation, return the surface
as near as possible to its condition before construction.

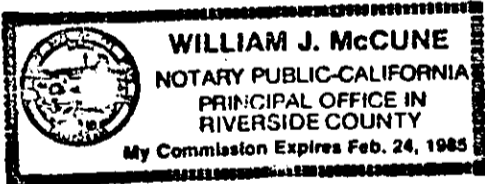
