FOR A VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, do ___ hereby grant to the CITY OF RIVERSIDE, a Municipal Corporation, the real property in the City of Riverside, County of Riverside, State of California, described as follows:

That portion of Lot 17, in Block 17, of Tract No. 3 of the Riverview Addition to the City of Riverside as shown by map on file in Book 7 of Maps at Page 5 thereof, records of Riverside County, California, being more particularly described as follows;

BEGINNING at the northwest corner of said Lot 17;

THENCE South 00° 01' 43" West along the west line of said Lot 17, a distance of 164.34 feet to the southwest corner of said Lot;

THENCE South 89° 58' 17" East along the south line of said Lot 5.00 feet to a line which is parallel with and distant 5.00 feet east as measured at right angle from the west line of said Lot 17;

THENCE North 00° 01' 43" East along said parallel line 152.87 feet to the beginning of a non-tangent curve concave to the southeast, having a radius of 29.50 feet; the radial line at said beginning bears North 63° 54' 27" West;

THENCE Northeasterly along said non-tangent curve through a central angle of 34° 21' 46" an arc length of 17.69 feet to the north line of said Lot 17, said north line being in a non-tangent curve concave to the south having a radius of 1,402.69 feet, the radial line at said point being North 03° 44' 50" West;

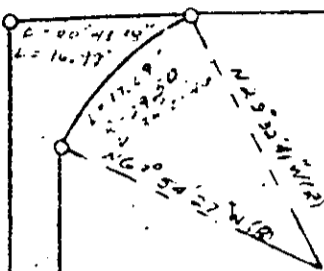

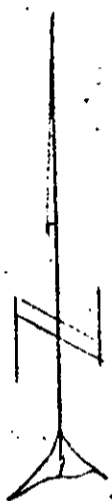
