SLOPE EASEMENT

FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged,

JAMES M. AUSTIN and VIOLA AUSTIN, husband and wife, and DAVID GOLDWARE
and JUNE GOLDWARE, husband and wife,

as Grantors, grant(s) to the CITY OF RIVERSIDE, a Municipal Corporation of the State of California, as Grantee, its successors and assigns, a perpetual easement and right of way for roadway slope and support purposes, in, on, under, through, over and along that certain real property situated in the City of Riverside, County of Riverside, State of California, described as follows:

All that portion of Lot 17 of The Resubdivision of Arlington Suburban Estates, as shown by map on file in Book 13, Page 75 of Maps, records of said Riverside County, more particularly described as follows:

BEGINNING at a point in the southeasterly line of said Lot, distant thereon North 55° 44' 09" East, 65.56 feet from the most southerly corner of said Lot; said point being the beginning of a non-tangent curve with a radius of 31.00 feet and concaving northeasterly;

THENCE Northwesterly and Northerly along said curve an arc length of 44.64 feet, thru a central angle 82° 30' 14" to a line which is parallel with and distant 47.00 feet east, as measured at right angle, from the centerline of Van Buren Boulevard;

THENCE North 0° 20' 40" East, along said parallel line 75.00 feet;

THENCE South 89° 39' 20" East, 5.00 feet;

THENCE South 0° 20' 40" West, 75.00 feet to the beginning of a tangent curve with a radius of 26.00 feet, concaving northeasterly and being concentric with hereinabove described curve;

THENCE Southerly and Southeasterly along said curve an arc length of 43.93 feet, thru a central angle of 96° 48' 29" to said southeasterly line of Lot 17;

THENCE South 55° 44' 09" West, along said southeasterly line 8.66 feet to the point of beginning.

Provided, however, that the Grantor(s) reserve(s) the right of use and enjoy the land over which said easement and right of way is granted, for any purpose and in any manner which does not interfere with or impair the right of the Grantee to use said easement and right of way.

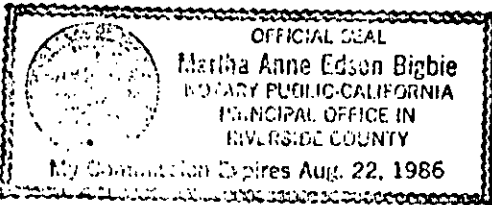

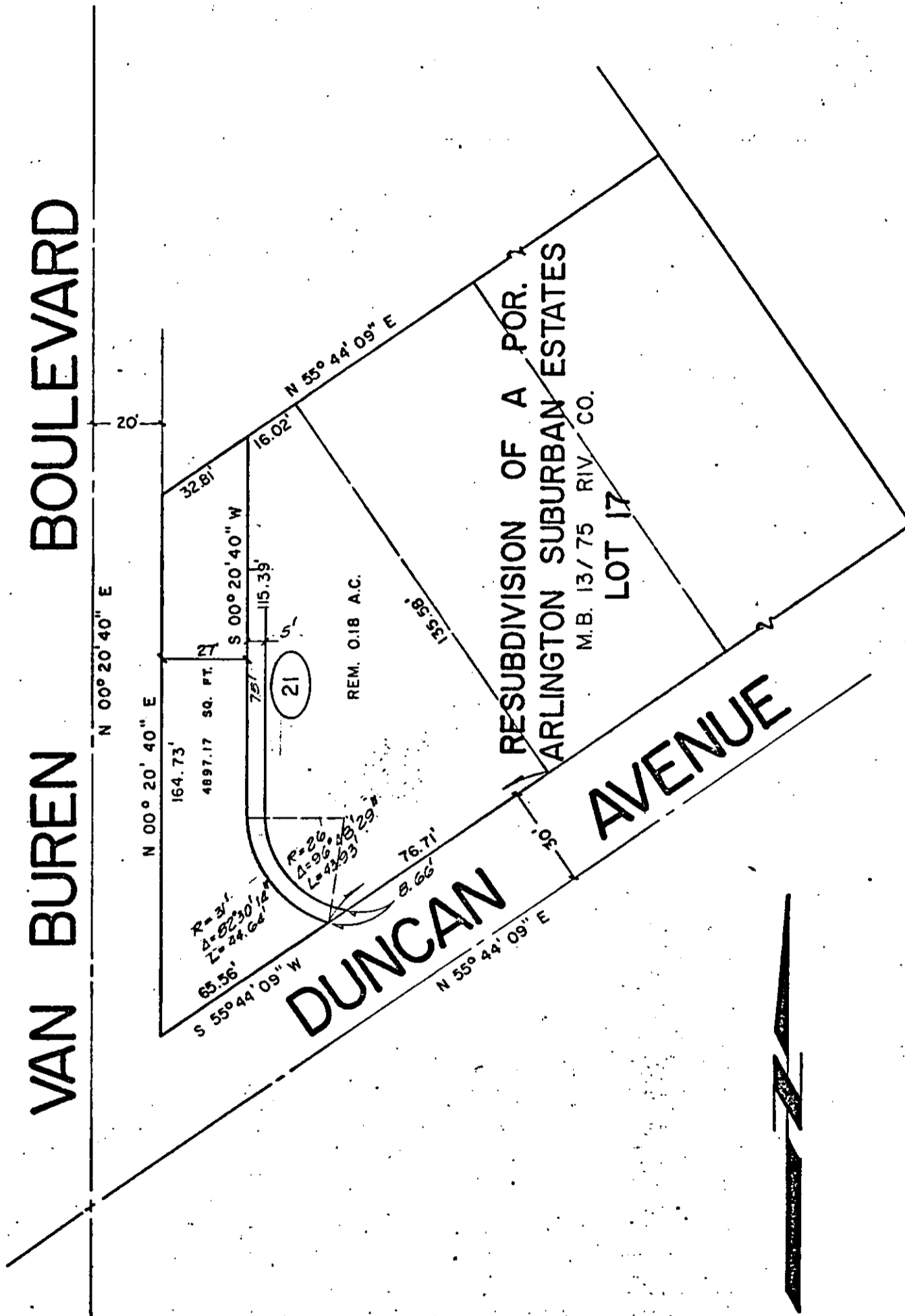
