RESOLUTION

WHEREAS, the real property hereinafter described was heretofore offered for dedication to public use for road purposes as set forth on the subdivision map herein-after referred to, which offer of dedication has not heretofore been accepted by the Board of Supervisors, and

WHEREAS, public convenience and welfare now require the use by the public of said real property for road purposes; now, therefore,

BE IT RESOLVED by the Board of Supervisors of the County of Riverside, State of California, in regular session assembled on April 4, 1966, that the offer of dedication of the real property hereinafter described, as set forth on the subdivision map hereinafter referred to, is accepted, and said real property is hereby declared open for the uses and purposes of county highways.

Said real property is in the County of Riverside, State of California, and is described as that portion of Barton Road, 30 feet in width, lying easterly of Lot 3, Block 10 in Section 17, T. 3 S., R. 4 W., S.B.M., as shown on map of the Alessandro Tract, filed in Map Book 6, Page 13, San Bernardino County records, beginning at the southerly line of Alessandro Boulevard, 142 feet in width, and extending to a point distant 1258.12 feet southerly of and parallel with the northerly line of said Section 17.

BE IT FURTHER RESOLVED that the real property hereinafter described was heretofore offered for dedication to public use for road purposes as set forth on the declaration of dedication hereinafter referred to, which offer of dedication has not heretofore been accepted by the Board of Supervisors, and

WHEREAS, public convenience and welfare now require the use by the public of said real property for road purposes; now, therefore,

BE IT RESOLVED by the Board of Supervisors of the County of Riverside, State of California, in regular session assembled on April 4, 1966, that the offer of dedication of the real property hereinafter described, as set forth on the declaration of dedication hereinafter referred to, is accepted, and said real property is hereby declared open for the uses and purposes of county highways.

Said real property is in the County of Riverside, State of California, and is described as the northerly 170 feet of said 30 foot dedication as recorded December 11, 1963 as Instrument No. 129546 in Book 3535, Page 32.

BE IT FURTHER RESOLVED that the Clerk of this Board is directed to cause a certified copy of this resolution to be recorded in the Office of the County Recorder of the County of Riverside, State of California.

DECLARATION OF DEDICATION
