RESOLUTION NO. 77-102

ACCEPTING WOOD ROAD AS A COUNTY HIGHWAY
(Fifth Supervisorial District)

5 WHEREAS, the real property hereinafter described was heretofore offered
6 for dedication to public use for road purposes as set forth on the subdivision
7 map hereinafter referred to, which offer of dedication has not heretofore been
8 accepted by the Board of Supervisors, and

9 WHEREAS, public convenience and welfare now require the use by the public
10 of said real property for road purposes; now, therefore,

11 BE IT RESOLVED by the Board of Supervisors of the County of Riverside,
12 State of California, in regular session assembled on March 22, 1977,
13 that the offer of dedication of the real property hereinafter described, as set
14 forth on the subdivision map hereinafter referred to, is accepted, and said real
15 property is hereby declared open for the uses and purposes of County highways.

16 BE IT FURTHER RESOLVED that the Clerk of this Board is directed to cause a
17 certified copy of this resolution to be recorded in the Office of the County
18 Recorder of the County of Riverside, State of California.

19 Said real property is in the County of Riverside, State of California, and
20 is described as follows:

21 PARCEL 1

22 That portion of Lot "H" (20 feet wide) lying northerly of the south line
23 of Lot 8, as shown on map of Olive Grove Park, as per map on file in Book 12,
24 page 61 of Maps, Records of the Recorder of Riverside County, California.

25 PARCEL 2

26 The westerly 30 feet of that portion of the northwest one-quarter of
27 Section 20, T. 3 S., R. 4 W., S.B.M. lying northerly of the easterly prolonga-
28 tion of the south line of Lot 8, as shown on the above referred Olive Grove
29 Park; and designated as a 30 foot wide street, as shown on Map of the Alessandro
30 Tract, as per map on file in Book 6, page 13 of Maps, Records of the Recorder of
31 San Bernardino County, California.
