1 On motion of Supervisor Hayden, seconded by Supervisor Lewis,
2 and duly carried, the following resolution was adopted:

3 WHEREAS, each parcel of the real property hereinafter described was here-
4 tofore offered for dedication to public use for road purposes as set forth on
5 the subdivision maps hereinafter referred to, which offers of dedication have not
6 heretofore been accepted by the Board of Supervisors; and

7 WHEREAS, public convenience and welfare now require the use by the public
8 of said real property for road purposes; now, therefore,

9 BE IT RESOLVED by the Board of Supervisors of the County of Riverside,
10 State of California, in regular session assembled this 8th day of September
11 1952, that the offers of dedication of the real property hereinafter described,
12 as set forth on the subdivision maps hereinafter referred to, are accepted, and
13 each parcel of said real property is hereby declared open for the uses and pur-
14 poses of county roads. Said real property, in the County of Riverside, State of
15 California, and is described as follows:

- 17 1. Lot F, an unnamed street, now known as Krameria Avenue; that
18 portion of Lot E, an unnamed street, now known as King Avenue,
19 lying southerly of Van Buren Boulevard, as now located; Lot C,
20 an unnamed street, now known as Williams Avenue; said Lots are
21 shown on Map of Fertile Acres, filed in Book 11, Page 71 of
22 Maps, in the Office of the Recorder of Riverside County, Calif-

lying southerly of the easterly prolongation of the southerly
line of Lot I, designated as Porter Avenue, and Lot K, designated
as Krameria Avenue, as said Lots are shown on Map of Woodcrest
Acres No. 4, filed in Book 15, Page 24 of Maps, in the Office of
the Recorder of Riverside County, California.
 4. Lot R, designated as Williams Avenue; Lots Q and J, designated as
