BE IT RESOLVED, FOUND, AND DETERMINED by the Board of Supervisors of the County of Riverside, State of California, in regular session assembled on April 5, 1983, 1983, that this Board accepts the offers of dedication and recognizes that said roads are public roads open for use by the general public.

BE IT FURTHER RESOLVED, FOUND, AND DETERMINED that this acceptance is for the purposes of vesting title in the County of Riverside on behalf of the public for public road and utility uses and is not an acceptance of the roads into the County maintained road system pursuant to Section 941 of the Streets and Highways Code; that said roads shall not become a part of the County maintained road system unless subsequently accepted into the maintained road system by resolution adopted by this Board.
