

## QUITCLAIM DEED

FOR A VALUABLE CONSIDERATION, receipt of which is hereby acknowledged,

E. L. YEAGER CONSTRUCTION CO. INC., a California corporation,

do hereby remise, release, and forever quitclaim to the CITY OF RIVERSIDE, a Municipal Corporation, the real property in the City of Riverside, County of Riverside, State of California, described as follows:

> That portion of Fremont Street of Tract No. 2 of the Riverview Addition to the City of Riverside as shown by map on file in Book 6 of Maps, at Page 63 thereof, records of Riverside County, California, described as follows:

COMMENCING at the southeast corner of Lot 3 in Block 5 of Tract No. 3 of the Riverview Addition to the City of Riverside as shown by map on file in Book 7 of Maps, at Page 5 thereof, records of said Riverside County;

THENCE North 00° 07' 15" East, along the easterly line of said Lot 3, a distance of 2.19 feet to a point in a non-tangent curve concave to the southwest and having a radius of 76.01 feet; the radial line to said point bears North 09° 58' 37" East;

THENCE Southeasterly, along said curve, an arc length of 15.61 feet thru a central angle of 11° 46' 07" to the TRUE POINT OF BEGINNING; said point being in the westerly boundary of said Tract No. 2 of the Riverview Addition to the City of Riverside;

THENCE continuing Southeasterly, along said curve, an arc length of 17.03 feet thru a central angle of 12° 50' 19" to a line which is parallel with and distant 15.00 feet easterly, as measured at right angle, from said westerly boundary of Tract No. 2 of the Riverview Addition to the City of Riverside;

THENCE North 00° 07' 15" East, along said parallel line, 156.35 feet to a point in the easterly prolongation of the northerly line of that certain parcel of land conveyed to the City of Riverside, a Municipal Cororation, by Deed recorded March 4, 1955, as Instrument No. 14538 of Official Records of Riverside County, California;

THENCE North 89° 52' 45" West, along said easterly prolongation, 15.00 feet to said westerly boundary of Tract No. 2 of the Riverview Addition to the City of Riverside;

THENCE South 00° 07' 15" West, along said westerly boundary, 148.36 feet to said True Point of Beginning.
