A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, CHANGING THE NAME OF A PORTION OF INDIANA AVENUE TO SAYWARD CIRCLE.

BE IT RESOLVED by the City Council of the City of Riverside, California, pursuant to the recommendation of the Planning Commission of the City of Riverside, that the name of a portion of Indiana Avenue located generally between Capitol Drive on the east and the Riverside Canal on the west, and described as follows:

That portion of Indiana Avenue bounded as follows:

Bounded easterly by the following described line:  
Beginning at the most northerly corner of Lot "I" of Tract 6756, as shown by map on file in Book 113 of Maps, at Page 59 thereof, records of Riverside County, California;

Thence South 79° 02' 14" East, along the northerly line of said Lot "I", 98.37 feet to the beginning of a tangent curve concave northeasterly and having a radius of 544.00 feet;

Thence easterly, along said curve, an arc length of 300.60 feet thru a central angle of 31° 39' 35" to a point in the southerly line of said Indiana Avenue and the end of this line description.

Bounded northerly by the following described line:  
Beginning at the most northerly corner of Lot "H" of said Tract 6756;

Thence westerly, along a curve concave southerly and having a radius of 456.00 feet (said curve being the westerly prolongation of the northerly line of said Lot "H") to the easterly line of the Riverside Water Company Canal and the end of this line description.

Bounded westerly by said easterly line of the Riverside Water Company Canal;

be changed to SAYWARD CIRCLE.

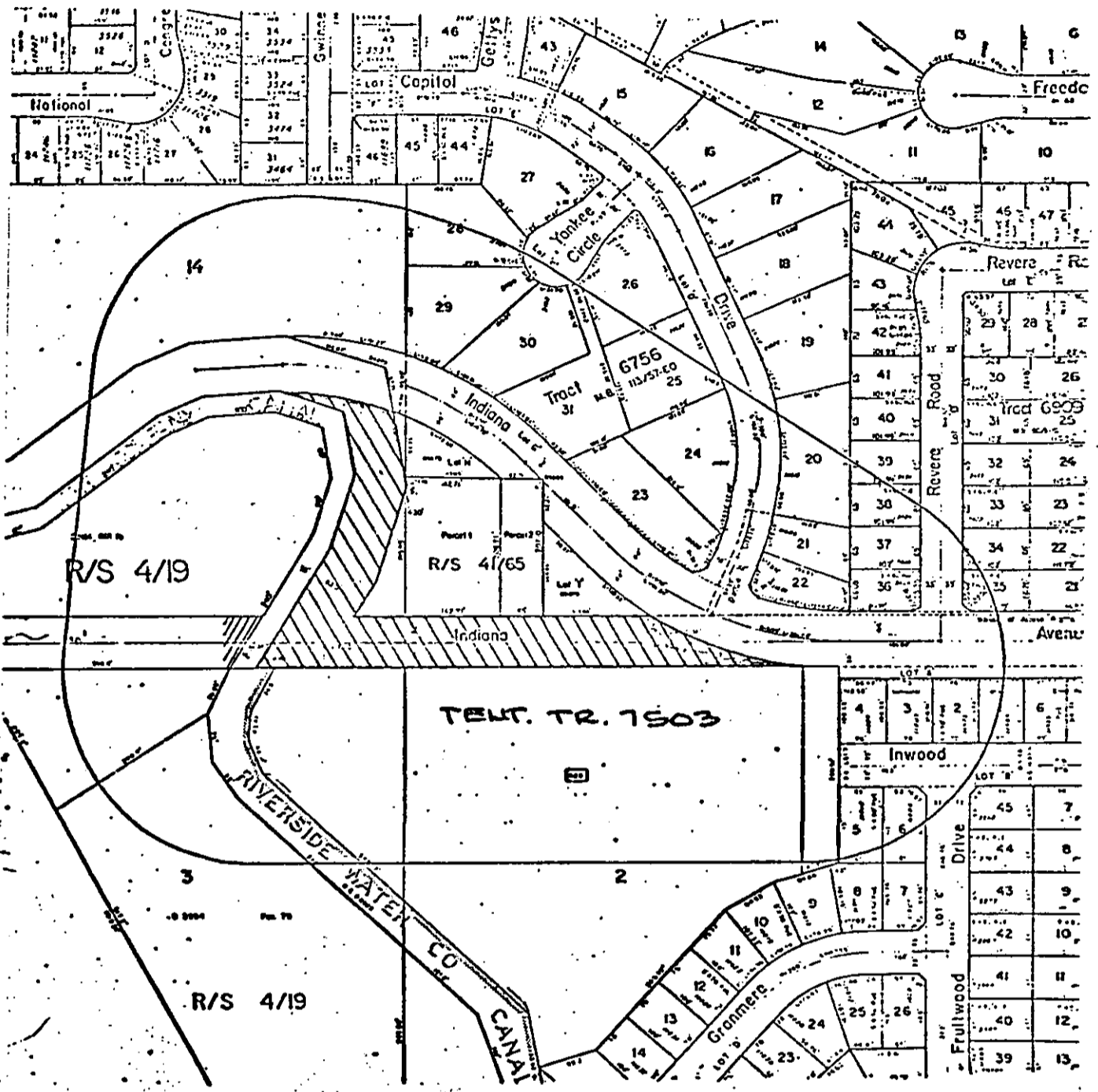

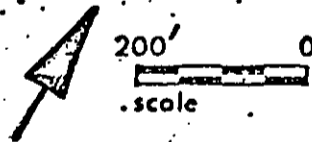
