A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACCEPTING A ONE-FOOT BARRIER STRIP WHICH WAS CONVEYED TO THE CITY OF RIVERSIDE BY DEED RECORDED FEBRUARY 16, 1983, AS INSTRUMENT NO. 20832 OF OFFICIAL RECORDS OF RIVERSIDE COUNTY, CALIFORNIA (WHICH BARRIER STRIP ADJOINS TRACT NO. 18368) FOR STREET PURPOSES TO BE KNOWN AS A PORTION OF BANBURY DRIVE.

BE IT RESOLVED by the City Council of the City of Riverside, California, that the following one-foot barrier strip is hereby accepted to public use for street purposes to be known as a portion of Banbury Drive:

That certain parcel of land conveyed to the City of Riverside for barrier strip purposes by Deed recorded February 16, 1973, as Instrument No. 20832 of Official Records of Riverside County, California, described as follows:

Those portions of Lots 11 and 14, Block 36 of the Lands of Riverside Land and Irrigating Company, as shown by map on file in Book 1, Page 70 of Maps, records of San Bernardino County, California, described as follows:

A strip of land 1 foot in width, lying south-westerly at right angles from the northeasterly line of Parcels 1 and 3 of a Parcel Map on file in Book 4, Page 85 of Parcel Maps, records of Riverside County, California.

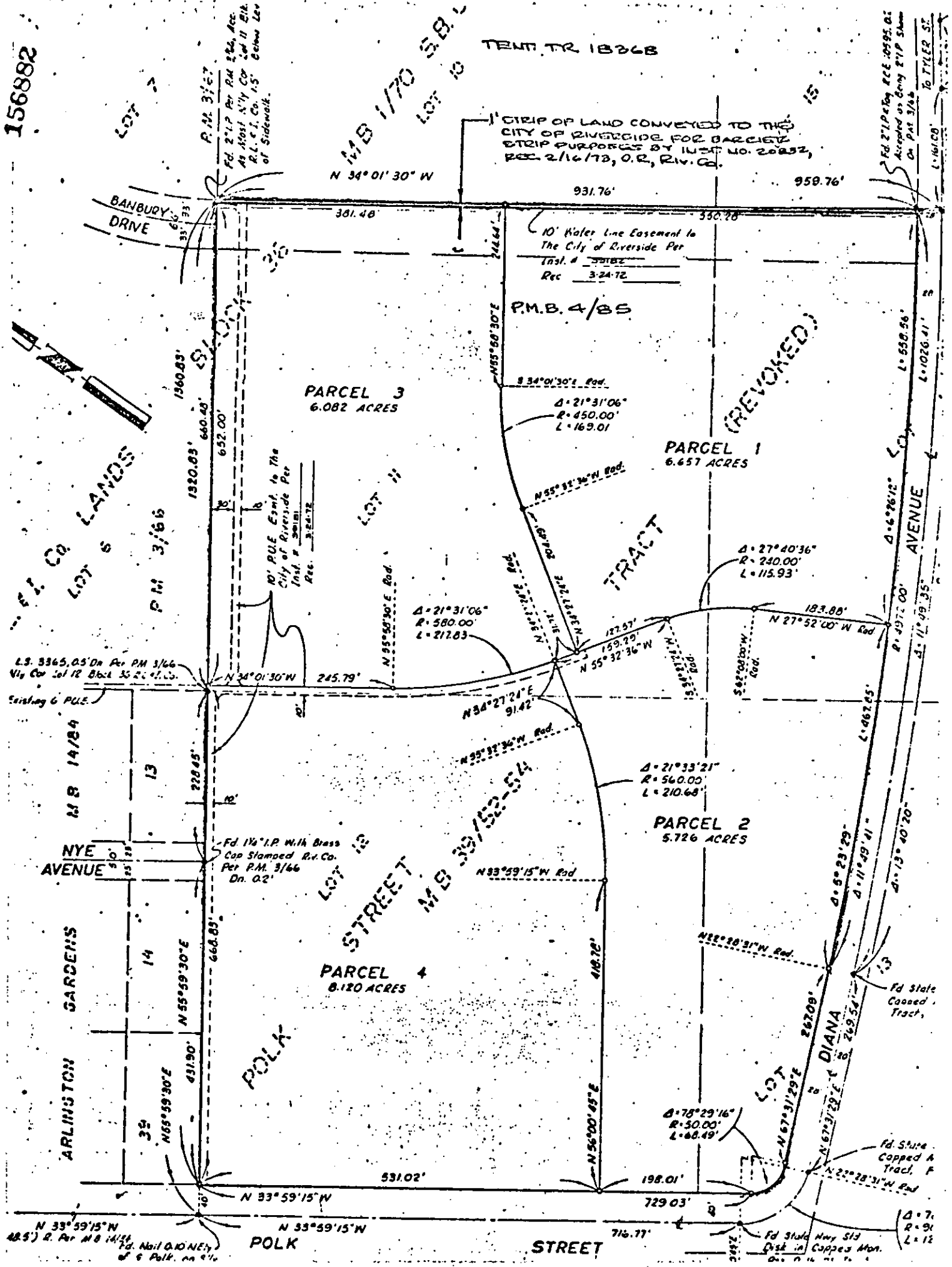
