ORDINANCE NO. 5114

AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA, CHANGING THE NAME OF A PORTION OF AUTO DRIVE TO DETROIT DRIVE. 10700

The City Council of the City of Riverside does ordain as follows:

Section 1: Pursuant to the recommendation of the Planning Commission of the City of Riverside the name of a portion of Auto Drive described as follows is changed to Detroit Drive:

That portion of Lot "A" (Auto Drive), as shown by Tract No. 2876, on file in Book 51 of Maps, at pages 74 through 76, inclusive thereof, Records of Riverside County, California, together with that portion of that certain parcel of land conveyed to the City of Riverside, a municipal corporation, by deed recorded December 5, 1969, as Instrument No. 124877 of Official Records of said Riverside County (said portion being more commonly known as Auto Drive), lying Northwesterly of the following described line:

COMMENCING at the most Southerly corner of Lot 6 of said Tract No. 2876;

THENCE N. 56° 00' 00" E., along the Southeasterly line of said Lot 6, a distance of 293.48 feet to the TRUE POINT OF BEGINNING;

THENCE continuing N. 56° 00' 00" E., along the Northeasterly prolongation of said Southeasterly line of Lot 6, a distance of 140 feet, more or less, to a point in the Northeasterly line of said parcel conveyed to the City of Riverside and the END of this line description.

Section 2: The City Clerk shall certify to the adoption of this ordinance and cause it to be published once in The Evening Press-Enterprise. This ordinance shall become effective on the 30th day after the date of its adoption.

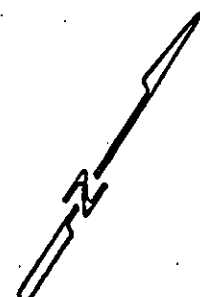
