A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACCEPTING CERTAIN ONE-FOOT BARRIER STRIPS WITHIN TRACT NO. 8510-1 AND TRACT NO. 4915 (WHICH BARRIER STRIPS ADJOIN TRACT NO. 8510-4) FOR STREET PURPOSES TO BE KNOWN AS PORTIONS OF SAGITTARIUS DRIVE AND BOUNDARY LANE.

BE IT RESOLVED by the City Council of the City of Riverside, California, that the following one-foot barrier strips are hereby accepted to public use for street purposes to be known as portions of Sagittarius Drive and Boundary Lane:

That portion of Tract 4915 as shown on map on file in Book 85 of Maps, at Pages 12 through 14 thereof, records of Riverside County, California, described as follows: Lot "J".

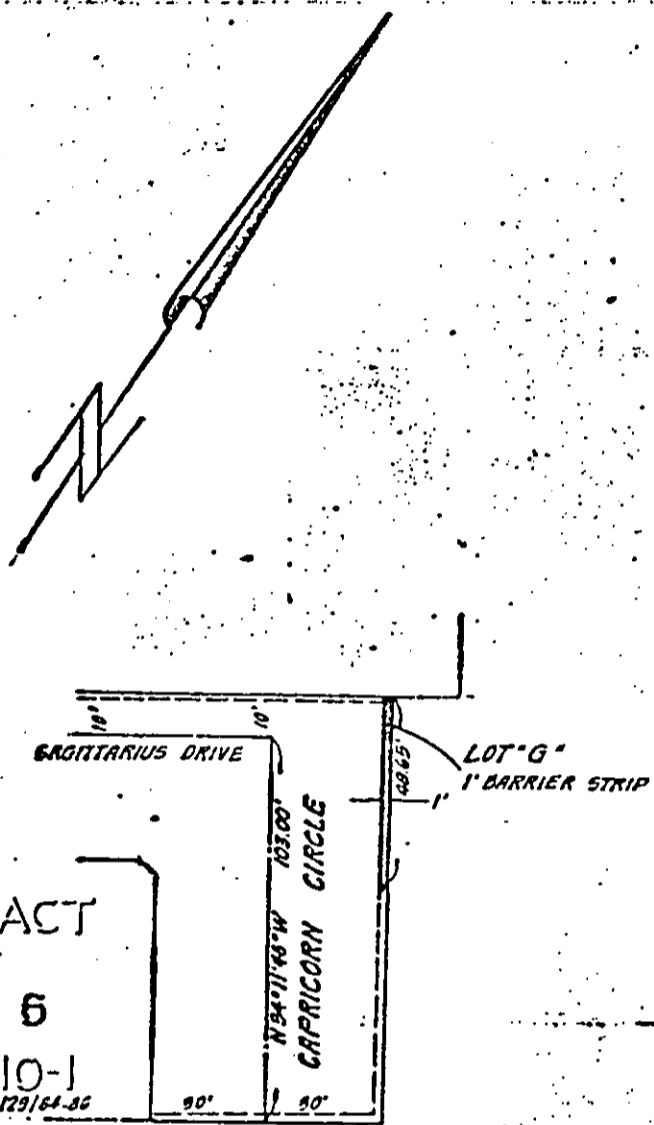

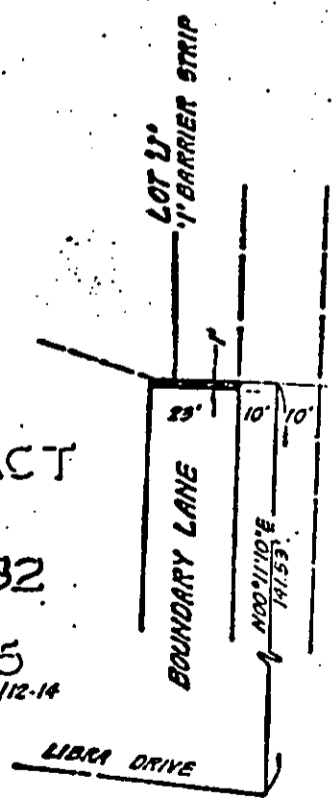
